PURPOSE OF THIS PROJECT, THE WORK AREA IS THE SECTION OF ROUTE 20 FROM THE INTERSECTION WITH ROUTE 148 TO THE INTERSECTION WITH NEW BOSTON ROAD.

Ms. Dumas read the legal notice.

Ms. Bubon stated that the Public Hearing last night represents an important milestone in a lengthy planning process. Ms. Bubon gave a brief overview of the events that have led us to this conceptual plan process with Pare Corp. She started with November 2008 and ended with where we are tonight.

Mr. Shevlin, of Pare Corp, stated that the CTDWG have been meeting on a regular basis with the Consultants to develop the conceptual plans for Route 20. In addition to the Working Group meetings, consultations with MassDOT and others, three well attended Public Forums have been held as a means of getting public feedback on the plans and to keep the general public and other Boards, Committees and Departments aware of the process.

The Consultants went through the slide presentation.

Mr. Shevlin thanked the Working Group, the Planning Board and the Planning Department for all their help with this project. It was a great working experience.

Ms. Gibson-Quigley stated that the task of the Board is to adopt the plan, present the plan to the BOS for their approval and then prepare for grants and funding.

The Board had the following question, concerns and comments:

- Outstanding job by the Consultants and a pleasure to work with
- Now that we have a conceptual plan, we can go forward with a serious plan and be put on the TIP with the Transportation Department
- How does a round-about work with traffic Mr. Thomson stated the traffic will keep moving
- Listened to the comments and incorporated them into the plan

- ADA compliant the Town is lacking with the sidewalks why the Town responsibility when Route 20 is a State road – Ms. McCabe stated that the Town needs to take the lead because people will complain to the local authority
- Doing this project in phases what will happen about being consistent throughout the plan with materials being used – Ms. Shadley stated that materials may change during this project but the look will always be consistent
- Why no sidewalks from Sturbridge Marketplace to Holland Road on south side – Mr. Thomson stated that because of the steep grade and guardrail there, it was better to use the sidewalk on the north side
- Trees and landscaping will cause a calmer traffic flow through the district
- Arnold Road Mr. Shelvin stated that a more in-depth study need to be done there because they realize that vehicles bypass that corner and exit at Cedar Street where there is a light

Ms. Desy of 489 Main Street is not in favor of this plan, and listed several concerns including issues with the round-about, digging up the street and sidewalk multiple times, why the need for 8' sidewalks the entire length, questions about actual costs including engineering, as well as concerns about the process.

Ms. Pecci of 138 McGilpin Road stated the Transportation Department is pushing for more people to walk and bike and this plan will do it. She also thanked the Consultants for a great job. She thinks the Town should look into the possibility of burying the electric lines in that corridor.

Mr. Suprenant of 14 LaFlamme Lane stated this plan will not solve the traffic problem and should look into expanding the roadway to four lanes.

Mr. Suhoski, the Town Administrator thanked the Consultants for a well done plan with a vision; and hopes the Town can move on to the next step.

Ms. Hart, Chair of the CTDWG recommended that the Planning Board vote to adopt the plan.
