# BOARD OF SELECTMEN MINUTES FEBRUARY 11, 2002

# **Budget**

Police Chief Thomas Button, Sgt. Tom Ford and Sgt. Alan Curboy appeared before the Board. Chief Button explained that the Police Department is short-handed in the area of full-time staff, and two additional full-time officers are needed. He said that the reserve program is not a cost effective way of dealing with the issue. It is necessary to train reserve officers for use of firearms, defibrillator, and corrections procedures, and last year it cost \$9,595 for that training. Also, it is difficult to keep reserve officers current, since there are often large gaps in their service. Last year one reserve officer went for a period of four months without working. Regarding level of service, a reserve officer does not get as much training as a full-time person.

Sgt. Ford and Sgt. Curboy gave the Board an outline of the shifts and expressed the need for additional full-time officers.

Chief Button informed the Board that officers spend 20-24 hours/week on clerical work, and indicated that they need more help in that area also.

The Board agreed to put a hold on voting on salaries.

# Stipends -

MOTION: To increase all stipends by 5%, by C. Blanchard.

The motion was defeated.

H. White noted that the purpose of a stipend is to cover the expenses of service on a particular board.
