# **Department Head Quarterly Reports**

Bev Poirier read her report to the Board (copy on file). She said that the fiscal 2004 tax rate was set on September 12, 2003. The bills were processed, stuffed and mailed on Sept. 30, 2003. The tax rate is \$18.68 an increase of \$1.07 over fiscal 2003.

Doris Sosik arrived at 6:40 p.m.

B. Poirier said that she receives the Building Inspector's monthly reports, but she would like to set up a different procedure for receiving information about occupancy permits.

Larry Adams reviewed his report with the Board (copy on file). He said that Radius Nursing Home at Estates North has not secured a commitment from the state for their financial allocation for the nursing home facility. The Allen Homestead project is moving along well. Regarding Lauren Ledge, some of the homeowners are not happy about having trees in their front yards, and there is one cobbled driveway which creates an impediment for DPW. The Sanctuary is moving ahead on schedule; the lots have been released, and some design reviews need to be done. The Preserve continues to sell lots. The Whittemore Woods project is before the Conservation Commission to seek approval for the wetlands crossing, and there are concerns regarding access onto Whittemore Road. The Planning Board plans to visit these subdivisions to review their progress. Regarding elderly housing, Empty Nest Housing behind Autumn Ridge is at the negotiating design stage.

L. Adams said that the GIS Committee met last week, and they talked with potential service providers. Vendors will be interviewed, and a selection will be made for digitizing tax maps.

Barbara Search reviewed her report before the Board (copy on file). A vinyl tile floor was installed in the dining area, kitchen and director's office, and a new carpet was installed in the small office, accomplished with money from the Friends Community Spelling Challenge, raffles, trip fundraisers, gifts from the Brodeur estate, Fleet Bank, Federated Church Koininia, and Walter Saletnik. All four bathrooms have been painted and decorated with matching borders, resulting in a pleasant, home-like décor. Hometown Bank donated \$300 for the project.

The original Formula Grant of \$5,414 for Sturbridge was increased to level funding at \$7,005.

# E. Osterman Inc. – Propane Storage Tanks

Ken Bailey of E. Osterman Inc. appeared before the Board. He noted that four 1,000 gallon propane tanks are proposed at Alsco Industries. The tanks will be located in the back corner of the property, and there will be crash protection for them.

## **Ask the Selectmen**

D. Schmida received a call from Kevin Smith, who asked the Board to discuss and describe why a TIF has been extended for OFS Fitel. J. Malloy said that OFS Fitel is a multi-national company that should be encouraged to stay in Sturbridge, since they bring jobs to the community, as well as property taxes. He felt that 1% would be a minimal investment by the Town. H. White added that OFS Fitel is the largest industrial employer in the Town of Sturbridge. A.Wilson noted that they make a significant investment in the community, and the Town is getting a benefit from taxes.

C. Blanchard received a call from Bill Muir, who expressed concern about whether or not the propane tanks were already part of the site plan. He said that they were put there before Site Plan review. Propane was part of the expansion.
