Warrington Property

J. Malloy provided the Board with a document to be signed (copy on file) on the Warrington property on Cooper Road, which the Board had opted not to exercise the Town's right of first refusal.

<u>Miscellaneous</u>

A. Wilson had asked about the vote taken last year to require Class II
dealers to provide better plans. J. Malloy submitted copies of the minutes
of the July 19, 2004 meeting and the December 15, 2003 meeting (copies
on file). Mr. Malloy's understanding was that this applied to new
applicants and not as an annual requirement for the applicants.

A.Wilson recommended that the Board sign the Class II licenses, then prior to renewing them next year, the licensees should provide better plans, indicating a description of the site, number of cars, and where they will be stored on the site. H. White said that when the licensees apply for their 2006 licenses, they should submit their plans by October 1, 2005, to give the Building Inspector time to review them; then the Board of Selectmen could act on them on the first or second meeting in December. It was the consensus of the Board that the plans need not be professionally done by an engineer or surveyor, but should be readable, clear layouts, and that the licensees be given a list of criteria to meet. J. Malloy agreed to put together a draft.

 J. Malloy had forwarded a memo with suggested updates to the Sturbridge Traffic Rules and Regulations (copy on file). He asked the Board to review the suggestions, to be discussed in mid-January. J. Malloy informed the Board that Fannin-Lehner completed their reports on the Old Burial Ground regarding the work that they accomplished this past year (copies on file).

Old Sturbridge Village – Change of Manager on Liquor License

Beverly Shepard of Old Sturbridge Village appeared before the Board. Their application was in order.

Malloy will set up a meeting with the police and fire chiefs, Deb Boyd and Michael Norton, then M. Norton will return to meet with the Board again on Tuesday, January 18, 2005.

Laurel Caouette of Sturbridge Isle appeared before the Board. The application was in order.

Old Business

J. Malloy noted that on the correspondence list there was a letter from the Attorney General in Connecticut regarding the Nipmuc petitions. He asked the Board whether they wanted to take any action on the matter. A. Wilson suggested asking Perkins-Coie for advice as to whether the Board should take

any action at this time. He noted that at some point the appeal process will end. C. Blanchard noted that the Board is against the casino, not against the recognition of the Nipmucs. He said that the Board should have a plan of what to accomplish, and policies and procedures should be followed properly. He suggested finding out how much money is available to spend.

- H. White asked about the status of the CPA appropriations. J. Malloy said that the CPA suggested trying to negotiate with the property owner, and if negotiations were unsuccessful, to go back to Town Meeting to rescind the debt authorization. Mr. Malloy agreed to set up a meeting after the holidays.
- C. Blanchard noted that there is a new restaurant sign near the Good News Garage. J. Malloy said that someone from Lola's Restaurant picked up an application for a Common Victualler license.
- D. Sosik asked whether the Sturbridge Bread Company is required to have a Common Victualler license. J. Malloy said that he would look into it.

A.Wilson reminded the Board that their reviews for the Town Administrator's performance evaluation are due on January 3rd .

Malloy said that sometimes a weather forecast is worse than what it turns out to be, and it is difficult to know what businesses are going to do, since there is no central clearinghouse for that kind of information. He said that he is usually very conservative about closings. A.Wilson said that he did not think it would be possible to draft a policy to cover all situations.
