Tom Chamberland, Tree Warden – Arbor Day 2005

A.Wilson read the Arbor Day Proclamation (copy on file); he also read the letter from Steven Pritchard, Dept. of Conservation and Recreation regarding Sturbridge's 16th consecutive Tree City USA Award.

T. Chamberland, Tree Warden, said that the 6th grade class at Burgess Elementary School will be bagging 1200 tree seedlings to be given out at Burgess and at the Recycling Center later in the week. He said that the Hachfeld family has donated a new White Birch tree in memory of their daughter, to replace the birch tree on the Common that has died. He informed the Board that Northern Tree Service will donate men and equipment to plant trees in front of the Public Safety Complex and along the entrance road to the Highway Department. The Rotary Club donated two trees. T. Chamberland and Steve Kelly of the Science Dept. at Tantasqua High School are developing a new urban/community forestry curriculum to introduce students to urban forestry.

Department Head Monthly Reports

Harold Nichols, Building Inspector, read his report to the Board (copy on file). H. White asked about the status of Empire Village restaurant. H. Nichols said that they had been issued a stop work order and cease and desist order. They will present new plans to the Planning Board, and the wetlands issue must be addressed before they are able to resume work at the site.

H. Nichols noted that there are a lot of signs posted around town that do not have permits, such as retail sales, home sales, etc.

H. White asked about the status of 548 Main Street. H. Nichols said that there was an issue with remodeling without a permit at the site. He met with the owner and talked to the State Inspector. There will be no changes to the building other than repairs.

Greg Morse, DPW Director, read his report to the Board (copy on file). J. Malloy said that Tighe and Bond will meet with the Board on May 2nd to review their progress report on well development and which option to pursue.

- G. Morse said that the PWED specs for Old Sturbridge Village have been completed. J. Malloy said that he has had discussions with Beverly Shepard, President of Old Sturbridge Village, and recommended that they do the education center first, then the front section as the second phase, followed by the remainder of the road. J. Malloy said that he has not heard back about the extension of the PWED grant.
- J. Malloy said that Veolia has started on weekends having the pump station on Hall Road pump to Southbridge. A. Wilson asked for an update on the numbers after two or three months.

Annual Appointments

J. Malloy informed the Board that Bob Briere has made arrangements to meet with the owner of property along the river, but he does not have the authority to negotiate acquisition of property on behalf of the Town. Mr. Malloy said that he would hold off on reappointing Bob Briere to the Community Preservation Committee until after he has met with him to discuss the matter. A.Wilson said that he would like to invite Virginia Belforte to the May 2nd meeting, since a few years ago she had been against tightening up the regulations on Town Meeting floor, and the Board needs to discuss the matter with her. It was the consensus of the Board to put the following appointments on hold: Bob Briere, Virginia Belforte (Design Review) and Charles Blanchard (Open Space Committee; Personnel Classification and Policy Committee).

Request to Apportion a Betterment Assessment

MOTION: That the Board of Selectmen, acting as Sewer Commissioners,

> approve the division of assessed land as provided for by Massachusetts General Laws, Chapter 80, Section 15 for land located at 3 Birch Street which is owned by Sean & Carolyn Crowell, recorded at the Worcester District Registry of Deeds, Book 35010, Page 146, which is to retain 100% of the original Cedar Lake Sewer Betterment Assessment and to assess 0% of the aforementioned Sewer Betterment Assessment lien to the 71,787 square feet of land, more or less, located on the westerly side of Birch Street, now known as 7 & 11 Birch Street, Sturbridge and shown as lots 1 & 2 Birch Street, Sturbridge on a plan of land entitled, "Plan of Land Located on

Birch Street and Old Hamilton Road by Land Planning Inc., dated 2/26/04, prepared for Jaredot, Inc. and recorded in the Worcester District Registry of Deeds in Plan Book 808, Plan 16, by A. Wilson.

2nd: H. White Vote: All in favor.

MOTION: To authorize the Town Administrator to execute any

documents that may be required relative to apportionment of betterment assessments on 3, 7 and 11 Birch Street, by A.

Wilson. 2nd: H. White Vote: All in favor.

Perennials Restaurant Liquor License - Change of Location

Rhonda Aspinall appeared before the Board. The application was in order.

MOTION: To approve the change of location application from Perennials

Restaurant for the new location at 420 Main Street, by H.

White.

2nd; D. Schmida Vote: All in favor.

MOTION: To close the public hearing, by H. White.

2nd: D. Schmida Vote: All in favor.

Sewer Extension Request

H. White recused himself from the Board.

Jalbert Engineering submitted a request on behalf of Rom's Restaurant for property at the corner of Farquhar Road and Route 131 to allow connections to town sewer for six new lots that are being proposed. Greg Morse, DPW Director, reviewed the design and approved it. He noted that in the event that town water is requested, the water pipes must lie in the same easement as the sewer pipes. Larry Adams, Town Planner, submitted his comments (copy on file).

Leonard Jalbert and Dan and Ginny Roscioli appeared before the Board. A.Wilson expressed concern about curb cuts and traffic safety on Rt. 131. L. Jalbert said that three driveways would be coming off Rt. 131 for those three sites. A. Wilson suggested that the Board hold action in order to study the situation and get more input regarding the curb cuts and the water issue. It was the consensus of the Board to hold action, and take it up again on May 2nd.

H. White re-joined the Board.

Town Meeting

Article 7 – Tantasqua Study Committee Report

J. Malloy read the recommendation from the Tantasqua Study Committee (copy on file). H. White suggested deleting the words "negotiate the actual terms" and substitute "further study of possible options." W. Emrich noted that the school system, pre-school through grade 12 is excellent, and that people move to Sturbridge because of the school system. He suggested a substitute motion that the Board of Selectmen continue dialogue with the Union 61 School District and the other towns in the district to work toward a solution to the assessment practices without withdrawing from the school district. H. White said that every penny goes to subsidize the other towns, and to continue the dialogue is a moot point. He noted that there is a lawsuit pending. W. Emrich said that he was concerned with an article that can't pass. A. Wilson said that the Board doesn't want to go with that motion and see it fail, then have no chance for dialogue with the other communities. J. Malloy said that H. White's change addresses that and removes the negative connotation. W. Emrich noted that the Town needs a new elementary school. He said that he could not support an article for Sturbridge leaving Tantasqua. J. Malloy said that it was a fiscal issue, and the Town will be voting to study what the cost would be, based on the terms of the withdrawal. H. White said that the Board has the responsibility to obtain all of the facts about this situation and the consequences of doing nothing. He said that the Town should be acting on the facts. It was the consensus of the Board to take no action on the article tonight, and to set a Board of Selectmen meeting at 6:00 p.m. on April 25, 2005 at the Tantasqua High School cafeteria.

Article 18 – CPC Affordable Housing Project

J. Malloy submitted to the Board Town Counsel's opinion (copy on file), which has been forwarded to the CPC and the Finance Committee. J. Malloy recommended that the Board vote that the Town take no action on the article, since it needs to be refined before it is brought back to Town Meeting. He said that the CPC should be congratulated for putting it together. H. White suggested notifying the Chairman of the CPC.

MOTION: To take no action on Article #18, by H. White.

2nd: D. Schmida Vote: All in favor.

STM Article #58

MOTION: To take no action on Article #58, by H. White.

2nd: D. Schmida Vote: All in favor.

J. Malloy said that for all other articles and budget items that the Selectmen have voted differently, he will have figures prepared and substitute motions for the Town Meeting.

Executive Session Minutes

MOTION: To release the minutes of 9/7/04 and 3/21/05, by H. White.

2nd: D. Schmida

Vote: Three in favor; W. Emrich abstained.

Old Business

A.Wilson asked whether J. Malloy had heard from Tighe & Bond relative to 55 Holland Road. J. Malloy said that he had not heard back from them yet, but will get an update for the Board on what is going on.

New Business

A.Wilson said that J. Malloy has invited the Planning Board to meet with the Board of Selectmen for the next work session.

A.Wilson said that J. Malloy will update the Board on the status of all of the lawsuits against the Town by May 21st. J. Malloy noted that 70% of them have recently been resolved.

A.Wilson said that he had received an invitation from Bob Briere to meet with Gerry Pacquin on April 20th at 5:00 p.m. He said that he would meet with them to listen, but not to negotiate. H. White said that he did not think that A.Wilson should meet with them on this kind of basis.

A.Wilson said that the Planning Board had given a presentation on Route 20. J. Malloy said that Larry Adams, Town Planner, did a Power Point presentation with the following highlights: a turnaround at Route 49; a median strip from Route 49 to the interchange with the Turnpike; a turnaround at Hall Road; two turnaround lanes at the Center at Hobbs Brook and pedestrian sidewalks to the shops. The Planning Board supported the recommendations of the Study Committee.

A.Wilson asked J. Malloy for an update on the Tantasqua Study Committee public hearing on April 12th. J. Malloy said that it was a positive discussion about what the vote would mean, and that it must be a win-win situation for all of the towns. H. White said that the Board of Selectmen should commend the members of that committee for the thorough job that they have done. He suggested that the minutes be posted on the Town's website.

A.Wilson asked J. Malloy for an update on the Informational Meeting in preparation for the Annual Town Meeting. J. Malloy said that it went very well,

with a very nice group of people. He felt that it would be worth doing again. The Town Moderator had put together a presentation with some practical and legal tips to help people understand Town Meeting procedures, and it is posted on the Town Administrator's web page under "Town Meeting Tips."

A.Wilson asked the Board to think about the composition of the Burgess Building Committee.

A. Wilson said that the Board has been invited to the Quinebaug Valley Art Center in Southbridge on May 6th.

A.Wilson said that Beverly Shepard, President of Old Sturbridge Village, would like to meet with the Board to discuss their vision for the future.

A.Wilson said that the latest MMA Action Bulletin requests that towns give their support to amendments to bills regarding the lottery and Chapter 70 funds. J. Malloy said that he would attend the MMA Fiscal Policy meeting next week.
