# BOARD OF SELECTMEN MINUTES AUGUST 1, 2005

The Chairman called the meeting to order at 6:30 p.m. following the Pledge of Allegiance. A.Wilson called for a moment of silence in memoriam of Leo Minette, who had served as Assessor for 30 years.

## **Tantasqua Regional School Committee Appointment**

A.Wilson asked the Sturbridge members of the Tantasqua Regional School Committee to come forward.

Francis Simanski appeared before the Board and Committee. He said that he has been a resident of Sturbridge for 21 years; for 15 years he was the principal of the high school; for six years he served as a high school teacher. He is now retired. He expressed his commitment to the schools. He has attended Tantasqua Regional School Committee meetings in support of the school district. He is familiar with policies, budget, personnel, and how committees work. He stated that he is committed to quality educational opportunities and fiscal responsibilities to the taxpayers of Sturbridge. His background is in education and educational administration.

William Haggerty appeared before the Board and Committee. He served as Assistant Principal at Quabog High School and as Superintendent; he retired last year. He expressed concern about the issues surrounding Tantasqua in the spring. He has been involved in a regional school district for 29 years, and has a good understanding of how it works. He said that he would bring objectivity to the committee, and is familiar with funding formulas and the mission statement, and noted the importance of good communication and collaboration with the community.

Michele Fitzgerald appeared before the Board and the Committee. She is a lawyer with Mirick and O'Connell, and has spent a lot of time on town issues, school committees, and has worked with the Connecticut teachers' union. She noted that Sturbridge has socio economic diversity and the benefits of a diverse curriculum and diverse student body. Her job skills include knowing when to be an advocate and when to compromise, and she has been involved in negotiations on many different matters. She said that the Tantasqua School District issue should be decided at the court level.

H. White said that relative to the email regarding Beverly Sheppard, Old Sturbridge Village, he suggested adding PWED to that, and recommended setting it up. J. Malloy said that he would do that.

A.Wilson announced that there is a hearing coming up on Old Sturbridge Village's request to rezone the area. J. Malloy said that he thought that it had already been passed by the Planning Board at their last meeting.

W. Emrich asked whether there had been a member of the teaching staff on the Tantasqua High School Building Committee. J. Malloy said that he would get a list of who had served on that Committee.

### **New Business**

A.Wilson noted that the latest MMA Action requested contacting legislators relative to the crisis in municipal health costs. He did not recommend that the Board take action relative to this tactic, since the percentage of health care is part of the bargaining process with unions.

A. Wilson asked the members of the Board to review the liaison assignments.

A.Wilson asked the Board for permission to direct the Town Administrator to proceed with the survey of the land on Stallion Hill, and to pay CME \$1800 out of the Lucent fund.
