S.Suhoski requested the Board to consider adding \$7,200 to line item #88 Building Dept. – Purchase of Services, whereas under any budget scenario the Town would need to continue with its contract with Charlton for a period of time into the new fiscal year while a new Building Inspector is recruited and hired.

MOTION: To approve an increase of \$7,200 to line item #88 Building Dept. –

**Purchase of Services, by T. Creamer** 

2<sup>nd</sup>: M. Redetzke Vote: All in favor.

S.Suhoski also requested the Board to add \$33,600 to line item #81 Fire Dept. – Salaries/Wages to cover the compensation of a temporary Deputy Fire Chief through the transitional period described in his memorandum dated June 3, 2013. The Board discussed the request.

MOTION: To approve \$33,600 increase to line item #81 for a new total of

\$629,548, by T. Creamer.

2<sup>nd</sup>: P. Gimas

Vote: Three in favor; M. Blanchard and M. Dowling opposed.

MOTION: That the Town Meeting should consider Article 3 as printed on the

warrant, by T. Creamer.

2<sup>nd</sup>: P. Gimas Vote: All in favor.

The discussion was that the Finance Committee's substitute motion does not provide for any disposition of the structure itself.

MOTION: That the Board of Selectmen does not support, and recommends no

action be taken by ATM on Article 20: Stabilization Fund, by T.

Creamer.

2<sup>nd</sup>: P. Gimas

Vote: Three in favor; M. Blanchard and M. Dowling opposed.

MOTION: That Article 54 of the STM be approved as written, by T. Creamer.

2<sup>nd</sup>: M. Blanchard Vote: All in favor.

The Board reviewed the Town Administrator's June 3, 2013 memorandum concerning various Fire Department transition items and discussed the recommendation of appointing retired Sturbridge Fire Captain Edward Bourassa as temporary Deputy Fire Chief.

S.Suhoski noted from his written report that, though retired since 2007, Mr. Bourassa has 16 years of command experience in the Sturbridge Fire Dept. (14 years as Captain from 1983-2007) and a lengthy list of trainings and certifications. He is also very knowledgeable about the local operations, but removed sufficiently from day-to-day operations to provide a fresh eye during this transitional period. He said Acting Chief Ford concurs with this recommendation.

- S.Suhoski proposed that the Board ratify his appointment of Edward Bourassa to the position of Temporary Deputy Fire Chief through January 17, 2014, at a salary of \$62,400 to be paid in weekly installments of \$1,200 (\$30/hour @ 40 hrs/wk).
- M. Dowling noted that she would vote against the motion, and that it was not personal. She said the appointee may very well be qualified, but that it should have been a listed agenda item. She also indicated that the Town Administrator had a duty to appoint an Acting Fire Chief first.
- M. Blanchard noted that the appointment was not on the agenda, and that everybody in the past has been blamed for the problems in the Department, and that she would prefer an outside candidate.
- T. Creamer noted that the recommendation of the Town Administrator came after the deadline for posting the meeting, so the Chair could not have reasonably foreseen the action. He said the current situation in the Department requires action, and noted that a majority of the Board voted to direct the Town Administrator to take "immediate" action at its May 29<sup>th</sup> meeting.

**MOTION:** To approve the appointment of Edward Bourassa to the position of

Temporary Deputy Fire Chief through January 17, 2014, at an annual

salary of \$62,400, by T. Creamer.

Vote: Three in favor; M. Blanchard and M. Dowling opposed.

MOTION: To adjourn, by M. Blanchard.
