Execution of Tax Increment Financing Agreement for 21 New Boston Road

- S. Suhoski informed the Board that the state Economic Assistance Coordinating Council is meeting at the end of June to consider the economic opportunity area designation and certified project application on behalf of Om Shri Ambika LLC (Holiday Inn Express) for the hotel project at 21 New Boston Road.
- S. Suhoski said that the TIF agreement has been signed by Jay Patel, principal of Om Shri Ambika, and reflected the same language as presented for the Town Meeting warrant and ultimately ratified at the June 2, 2014 Annual Town Meeting. The EACC requires the Town to submit the signed TIF by Wednesday, June 18th or the matter will be deferred until late in September.

Water/Sewer Operations Contract

S. Suhoski said that he is working with Town Counsel and Veolia Water North America to develop the final language for the successor contract. He will bring it forward when the parties reach agreement.

One item raised at the last Board meeting was whether the Town could obtain a series of five, one-year options rather than the two, five-year option periods in the initial Request for Proposals. Veolia has advised that the change would not be acceptable. If the Town is not satisfied, it can simply re-bid the entire operations and maintenance

prior to the expiration of the first five-year period. There is no obligation whatsoever to continue beyond the initial term if it is not in the interests of the Town.
