Summary – This article is to undertake the renovation of the Town Hall and Center School Building. In 2002, the Town Meeting appropriated funds to conduct architectural and engineering studies for the re-use of the Center School Office Building and the Town Hall. The Selectmen created a study committee that met for a year with the architects and engineers and all departments in the Town Hall were consulted as to their space needs. The final concept plan was to move the Board of Health, Planning, Zoning, Building Inspector and Conservation Commission offices into the Center School with an additional public meeting room for their public meetings. The Town Hall would house administrative and finance offices with the "high traffic" departments on the first floor and the "low traffic" offices on the second floor. The Town Hall renovation includes two conference rooms and a larger vault in the Town Clerk's office and structural and exterior repairs.

When the committee presented the final recommendations to the Board of Selectmen, it came at the same time as the recession and cuts in state aid. At that time the Board of Selectmen opted to hold off on the renovation plans until such time that they felt the Town could afford to go forward with the renovations. There is a ballot question to exclude the debt service from Proposition 2 ½ which would be necessary for the Town to approve this article. At this time, the Town's General Fund has no long-term debt.

THE VOTE OF THE TOWN MEETING: The vote of the Town Meeting was to approve the article as recommended by the Finance Committee by a 2/3rds majority in favor as declared by the Moderator.

ARTICLE 8 CAPITAL EXPENDITURES – DUMP TRUCK/LOADER DEBT ISSUANCE (2/3 vote required)

To see if the Town will vote to appropriate the sum of TWO HUNDRED SEVENTY NINE THOUSAND SEVEN HUNDRED DOLLARS AND 00/100 DOLLARS (\$279,700.00) to purchase a dump truck to replace the existing H-12 dump truck and to purchase a replacement for the loader used by the Public Works Department and Landfill/Recycling Center, including costs incidental and related thereto, and to determine whether the appropriation shall be raised by borrowing or otherwise; or take any action in relation thereto.

Summary — This article is in keeping with the Town's fiscal policies for borrowing on a short-term basis for larger capital items that exceed \$100,000. The Town borrows for a period of five-years for these capital items. Both of these purchases were part of the review conducted by the Capital Planning Committee and were rated high enough to be purchased in FY07. The Town presently needs two new loaders, one at the landfill and one for the Public Works Department. The Town will be shifting the loader currently used by the Public Works Department to the landfill and is proposing to purchase the new loader for the Public Works Department.

VOTE OF THE TOWN MEETING: The vote of the Town Meeting was to approve the article as recommended by the Finance Committee by a 2/3rds majority in favor as declared by the Moderator.

Summary – Although this is a Charter issue, MGL Chapter 121B, §3 "Housing Authorities; creation; dissolution" requires that the matter of dissolution be considered at an Annual Town Meeting. All other Charter Review Committee articles will appear on the Special Town Meeting warrant. The Sturbridge Housing Authority was created in the 1970's but has never developed any low income housing projects and does not own any land. During the past year, the Housing Authority has discussed the dissolution of the Housing Authority and the creation of a Housing Partnership Committee that would focus more on affordable community housing in keeping with the Community Preservation Act and developing and advocating for inclusionary zoning in new subdivisions to include affordable housing.

VOTE OF THE TOWN MEETING: The vote of the Town Meeting was to approve the article as written by a 2/3rds majority as declared by the Moderator.

This provision is effective for all approvals granted after January 1, 1995."

In some instances, projects take years or never start construction. This bylaw would provide a timeframe in which sewer flow reserved for a specific project would expire, allowing the Selectmen the ability to allocate sewer flow for other projects.

VOTE OF THE TOWN MEETING: There was a substitute motion made by Kathy Neal to delete the last sentence of the article, "This provision is effective for all approvals granted after January 1, 1995." This motion was seconded and the vote of the Town Meeting was to approve the article as amended as declared by the Moderator.

"Sewer extensions to new lots shall expire two (2) years after the extension is approved by the Board of Selectmen if work has not been substantially initiated, as determined by the Board of Selectmen unless an extension has been granted by the Board of Selectmen. This provision is effective for all approvals granted after January 1, 1995. All sewer extensions shall require a public hearing with the public hearing notification printed in the newspaper designated by the Town, at least two weeks prior to the public hearing."

After discussions with the MA Dept of Environmental Protection, Tighe & Bond has indicated the Town will need to conduct a CWMP, which includes evaluating the needs of the town over the next 20 years; to deal with more stringent permit requirements; to review infiltration/inflow; evaluate on-site treatment for future growth; evaluate the need for future expansion; evaluate the long-term effectiveness of the intermunicipal agreement with Southbridge and generally providing essential planning data and maps for the Town's sewer infrastructure. The last time a review of this scale was undertaken was the 1978 Facilities Plan conducted by Tighe & Bond.
