

Sunapee Conservation Commission Meeting Minutes March 2, 2016

Muffin Bushueff, Susan Parmenter, Timothy Bushueff were present to discuss and inform the Sunapee Conservation Commission on the proposed Bobcat hunt. We were informed on the groups involved in the decision, the State Rep vote count, lack of science presented on the subject, 10,000 signature pole signed against the hunt, lack of supportive reasoning for the opening of the Bobcat season. There is a JLCAR hearing at the Representatives hall at the Statehouse in Concord on April 1, @ 9am, this is the final process to making this proposed Fish and Game Bobcat hunt a law. Sunapee conservation was given information regarding the Stoddard Conservation Commission stance against supporting the Bobcat Hunt for the State of NH encouraging other conservation commission around the state to voice their opposition to the proposed hunt. Gerry Tracey made the motion that the Sunapee Conservation Commission write a letter in opposition of the Bobcat hunt. Lela Emery seconded the motion. All in favor 4, opposed 0. Van will draft the letter on behalf of the SCC.
