Rem Mastin made the motion to accept the Minutes as written from April 2015 meeting. Robert Hill seconded the motion. All in favor 5.

Second Public Hearing for Wendall Marsh South is scheduled for May 18, 2015 at 7:00 pm at the Sunapee Town Office.

ASLPT have noted the funding for the Wendall Marsh South.

ASLPT \$ drive = \$40,640 (need clarification on a \$5,000 Grant listed)

SCC committed= \$68,000 (reduced from \$75,000)

Warrant Funds= \$55,000

\$123,000 Total number required from Sunapee CC for closing

SCC members reviewed the Treasurers Report from Lynne of current account and balance.

CCF = \$121,808.13 and the Bartlett Tyler Fund = \$29,029.47 these two accounts will fund the Wendall Marsh South project. These two funds are expendable by a vote of SCC.

Tim Fleury made the motion that the Sunapee Conservation Commission vote to expend \$123,000 not to exceed \$123,000 subject to final accounting for the purchase of Wendall Marsh South. SCC will reduce the amount if additional funds come in. Motion seconded by Rem Mastin. All in Favor 5.

Tim Fleury made the motion to withdraw \$100,000 (One Hundred Thousand Dollars) from the Conservation Commission Fund and \$23,000 (Twenty Three Thousand) from the Bartlett Tyler Fund for the purchase of Wendall Marsh South. Robert Hill seconded the motion. All in favor 5.

Closing date for Wendall Marsh South is scheduled for June 1st. SCC will be notified of final number reflecting any additional Fundraising which would reduce our commitment.

Rem Mastin made the motion to pay the invoiced SCC received to pay the Town of Sunapee for the public hearing notices for Wendell Marsh South printed in the Intertown Record. Funds should be taken from the General Fund. Robert Hill seconded the motion.

Robert Hill made the motion to pay SPNHF the balance of \$80.00 as a donation from the membership budget line. Seconded by Rem Mastin. All in Favor 5.

A resident has expressed an interest in the Conservation Commission. Van will invite her to visit our next two meetings for June and July to see what we do.
