SCC members have been notified of tree mortality along the fence line at Dewey Beach. It has been reported that there are piles rock salt around the hemlocks. This is the second time vegetation has been purposely killed on the Dewey Beach Property. Police reports have been filed.

The request by Mt Royal regarding fields. SCC has concerns with Donor intent and would like the family contacted for input since their families legacy. The role of the Society for Protection of New Hampshire Forests needs to be addressed. SCC is opposed to the sale – SCC represents open/natural space. This should be a public process.
