Minutes from the July 09th meeting were read and M. Scott made motion to accept with two corrections, D. Ramspott second, the motion passed.

D. Ruggles made a motion to enter Non-Public Session, M. Scott second the motion, the motion was approved. The BOE entered Non-Public Session at 19:05.

After Re-entering Public Session;

D. Ruggles Reported;

- Bradford Road dry hydrant is leaking air and creates a whirlpool when used. Other comments were that it may be too light weight.
- Still waiting for the Grant Money to pay for the new Compressor.
- The R.I.T. Pack is in, but may still be missing the "rope bag".
- Discussion with M. Scott about Bailey House Training.
- There are two hydrants that are still "Out Of Service". One in Georges Mills and one in Sunapee Harbor.
- Planning to have Propane Training in September (actual date pending). Asking Lance to conduct "Classroom" beforehand.
- Sunapee Cove Fire Alarm work is pending the progress of the building, will let everyone know in advance. The Sprinkler System in the new part of the building will be a separate system from the main Building.
- Sunapee Cove to have "Active Shooter Training" and "Evacuation of Entire Building Training". First as a "Table Top Exercise", then the actual Drill, now scheduled for January.
- Hazmat Day Training September 4th & 5th in Concord at NH Fire Academy.
- September 29th at the VT Fire Academy will be Fire Chief Instruction.
- Discussion of the upcoming 250th Celebration, Fireworks, Musical Event, Footrace & Parade, all of which will need SFD Work Details.
- Asked about "Organization Committee progress.

H. Sargent stated that the Osgood/McAllister Gift paperwork had been delivered to the Town Manager for review. Also made a few comments about the "Pump Training". Also asked about the "Care Track" expansion.

M. Scott presented a review of the upcoming training for September & October.

D. Ramspott asked about repairs to the ceiling over the boat in the App Bay.


D. Ramspott made motion to adjourn the August meeting of the Board of Engineers, M. Scott 2nd, meeting adjourned at 19:45.
