

Sunapee Sestercentennial Committee
January 9, 2019 7pm Sunapee Town Office Meeting Room

Present: Kathy Springsteen, Steve Marshall, Becky Rylander, Ron Garceau, Dana Ramspott

No motions were made and no votes taken due to lack of quorum.

Delayed Action: Approval of December 10, 2018, minutes.

The group discussed the draft policy for town use of photographs.

The photographs on this thumb drive are the property of the Town of Sunapee. Permission for use of and/or reproduction of the photographs is given to patrons of Sunapee's Abbott Library for personal use only. No commercial activity or posting of photographs on social media is permitted unless permission is obtained from the Board of Selectmen of Sunapee, NH.

It was decided to draft a second policy that allowed for posting of photographs on social media if the photograph/s contained only family members of the person doing the posting. Both policies would be sent to Donna Nashawaty for her input and Selectboard input if deemed necessary. The Committee will accept their advice and decision about the policy and move forward to make the photographs available to the community.

The group discussed the town request to suggest photographs for use on the cover of the town report. Suggestions included the quilt, the top of the time capsule, time capsule burial, parade, fireworks, and musical concert. We decided to present a collage of pictures with the time capsule plaque in the middle for town consideration. Ron and Steve will work on this. Kathy (and others if they like) should send pictures to Ron and Steve for possible use.

Kathy distributed a draft of a report for the town. It is due immediately and needs editing. Comments were given and members present agreed to read and send additional comments and corrections to Kathy. Kathy will also ask Patricia Halpin and Sharon Parsons to use their excellent editing skills to improve the draft.

Dana reported that the town would be interested in Committee input on disposal of unsold commemorative items. At present we have 14 decals, 16 license plates, 96 stamps envelopes, and 110 arrowheads. Dana suggested that Betty talk to Pam Stocker about Sunapee Graniteworks taking over sales of arrowheads and how that might best be accomplished. It was noted that, in the end, the decision of what to do is now the town's to make and not the committee's and we would only be making a recommendation or expressing an opinion.

Dana reported that he had been contacted by the Springfield NH Sestercentennial Committee about using the bunting that Sunapee has purchased. Again, it was noted that this must be a town and not a committee decision. The Committee could discuss making a recommendation.

Steve asked about drone pictures because none have been received. Dana said he would contact Mr. Ryba and see if any photographs taken by the drone at the closing ceremony are available.

Because the Committee was unable to make any decisions at this meeting, there will need to be another meeting. We decided to wait until we had the town's recommendation on the photograph policy and then try to schedule a meeting. It will be important that enough members be present to have a quorum. Food was suggested as an enticement.
