- Motion Mr. Kushi to open TOBACCO REGULATIONS PUBLIC HEARING, 2<sup>nd</sup> Ms. Paciorek, Vote 3-0.
  - There are two (2) business owners present at the hearing. Owners acknowledge received proposed changes:
    - 1) Sales age increase to 21 years
    - 2) Eliminates sales of flavored tobacco products
    - 3) No sales within 500ft of a school
    - 4) Definition changed to include all combustible products including e-cigarettes
    - 5) Board of Health can revoke permit if egregious violations
  - Owners expressed concern about changing the age to 21 years. Second concern was eliminating flavored tobacco products. Last concern was the Board's ability to revoke a permit.
  - o Ms. Rock, Board of Health Chair addressed the legal right to protect the youth/young adults of our community.
  - Sunderland Mark owner expressed economic concerns because of the proposed changes.
  - o The Chair acknowledges letters of support for consideration received from the following: Dr. Ilina Schmitt from UMASS and Sunderland Resident; Town of Shelburne Board of Health; Town of Whately Board of Health; Franklin County Regional Council/Partnership for Youth; Tobacco Free Mass organization; Mas Rangelformer U.S. Marine Sgt. and Columbia University student; HRCOG; American Heart Association; Dr. Ruth Potee of the Town of Greenfield.
  - o Motion Mr. Kushi to close HEARING, Ms. Paciorek 2<sup>nd</sup>, Vote 3-0.
  - Ms. Paciorek Motion to accept draft regulations dated October 2015 as to supersede the previous regulations. Date of effect for regulations is January 4, 2016, Mr. Kushi 2<sup>nd</sup>, Vote 3-0.
