- Moment of History-Mr. Fydenkevez 1959 Annual Report-Report of the Superintendent of Schools that education is focusing more on math and science.
- Sunderland Public Library (SPL) Budget Hearing-Lorin Starr- Overview of budget request. SPL was without director for some time this fiscal year. Discussion regarding part-time wages, substitute wages and ability to distribute funds so recommended appropriations can be met. Discussion regarding staffing and competitive wages. Capital request for purchase of photocopier. Discussion regarding technology vs. "materials"; purchase vs. lease. Mr. Fydenkevez-wants to bundle buying/leasing on copiers. Discussion regarding Special Town Meeting request for appropriation transfer from Director Salary to Library Expense to purchase materials.

- FY13 Baseline Budget-Mr. Bergeron-important to keep budget requests as of deadline in the budget until budget hearings. Mr. Fydenkevez-people need to be aware of what's in the budget, and understand impacts in departments. Need more public involvement. Mr. Pierce-Town-wide pent up need for things that have been put off for a long time. Mr. Bergeron-this is last opportunity for Board of Selectmen to put ballot questions on election ballot. Suggest placing capital override question. Mr. Fydenkevez-resident suggested trying a smaller amount \$20-25K. Mr. Pierce-Capital projects are items we know the Town needs. Discussion regarding programmatic approach to funding capital; override vs. borrowing costs. Discussion regarding importance of addressing capital needs and reinforcing that TM vote is required for appropriation. Motion to present ballot question for capital stabilization override of \$30,000 by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 3-0.
