- Call to order at 7:07 pm.
- Veterans' Memorial Dan Vandalsen received three quotes for stump removal and planting of 9 trees at the Veterans' Memorial and one at the Elementary School. Motion to approve the expenditure of up to \$3,500 for the work by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0. Discussion regarding pruning the yews. Mr. Vandalsen-landscape architects will be at the Veterans' Memorial when the trees are planted, and can recommend yew maintenance then. Motion to wait for landscape architects' recommendation by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0. Mr. Vandalsen-request for \$280 in addition to originally approved sum not to exceed \$3,500, for the purchase of nine 3" diameter trees. Discussion regarding diameter and cost of trees. Mr. Fydenkevez-talk with Brian Kane before making the purchase. Mr. Vandalsen-engraving is scheduled for next week. C-5 flyover on Thursday, Nov. 8th at 10:30 a.m. during the Veterans' Memorial ceremony.
- August 20, 2012 Minutes- Motion to accept as presented by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- Over-the-Street Banner Permit Application Fee and Form Approval Motion to set banner permit fee at \$75.00 by Mr. Pierce, 2nd by Mr. Fydenkevez. If the Highway Department has to rent a bucket truck to hang and remove a banner, the rental cost must be borne by the sponsoring organization. Vote 2-0.
- Board of Selectmen's Fall Meeting Schedule Weekly meeting schedule begins effective immediately.
- Fall Festival Banner Permit Application Janet Conley-Single-sided banner, 30'w x 3'h. Review of regulations. Motion to waive \$75 banner permit fee for this application by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0. Fall Festival Committee would be responsible for bucket truck rental cost if necessary. Motion to approve banner permit by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- Pole Hearing (1) jointly owned pole on Burek Cross Road. Legal notice read by V. Chair, Mr. Pierce. Walter Chudzik, WMECO-setting 40' class II pole. Looking to do install by end of the week. Location is staked. Discussion regarding pole hearing procedure. Mr. Chudzik hasn't talked with Highway Superintendent yet. Will contact him tomorrow morning, Highway Superintendent will call Board's office to confirm acceptance, and Board's office will contact Mr. Chudzik. Public Hearing closed. Motion to approve pole location contingent on Highway Superintendent approval by Mr. Pierce, 2nd by Mr. Fydenkevez. Completed pole hearing checklists to be included with hearing materials in the future. Vote 2-0.

Electronic agendas iPads would conserve paper and allow more flexibility in presentations.
