- Call to order at 7:09 p.m.
- 'All Boards' Meeting-Master Plan was last done in 1974. Mr. Fydenkevez-overview of past master plan development and updates coordination. Mr. Bergeron-Town wasn't eligible for LAND grant due to outdated Open Space & Recreation Plan. Other grants awards may be dependent on updated plans. Mr. Pierce-Master Plan gives the Town tools for moving forward. Discussion regarding plan updates and relation of infrastructure to development. Steve Schneider-Planning Board has worked over the last few years on C-1 changes to encourage economic development while maintaining Town's character. Curt Griffin-UMass LARP program may be able to help with plan updates through a semester studio project. Lorin Starr-this may be impetus for boards to gather information together to get ready for compilation. Discussion regarding process; planning, i.e. transportation; establishing baseline to identify where Town is at now, and requirements to update information; coordinating multi-department efforts; GIS implementation.
