- April 1, 2013 Minutes-Motion by Mr. Pierce to accept the minutes, 2nd by Mr. Bergeron. Vote 3-0.
- Annual Town Meeting (ATM)
 - o Frontier Capital-Discussion regarding requested items in Frontier's capital submission. Mr. Pierce-inclined to support request minus pick-up truck. Mr. Bergeron-options are to move to not include, modify down the warrant request, or include and frame motion to support "X". Mr. Fydenkevez-suggest putting on warrant as presented, but amend at town meeting to provide for safety and security updates. Motion to include article by Mr. Bergeron, 2nd by Mr. Pierce. Vote 3-0.  - FY14 Budget (SPL request to reduce FY14 Building Operating by \$1,670 and increase Library Expense by \$1,670) - Mr. Fydenkevez-would like to be notified if Reserve Fund transfer comes in for Building Maintenance. Discussion regarding building operating needs. Other updates-Board of Assessors salary at 2% requested increase; Ambulance Reserve funding to remain at FY13 level.
 - o Special Town Meeting (STM)-combine ATM and STM. Motion to cancel STM and place the 2 articles-Unpaid Bills of Prior Fiscal Years and Snow & Ice deficit, on ATM warrant by Mr. Pierce, 2nd by Mr. Bergeron. Vote 3-0. Include ATM start time 6:30pm on warrant.

 - o Quinn Rescission-Motion by Mr. Bergeron, 2nd by Mr. Pierce. Mr. Bergeron-Beneficial to Town and Police Department personnel to not be at the mercy of state contribution. Vote 3-0.
 - o Quinn State Portion funding Petition-Discussion regarding backfilling state aid. Mr. Fydenkevez-at town meeting where Quinn was accepted, assurance was made that Town funding would not be pursued if State reneged on its statutory contribution.
