- Call to order at 6:30 p.m.
- Executive session MGL c.30A, § 21, ¶2 read by Chair, Mr. Bergeron. Motion to enter into Executive Session by Mr. Pierce, 2nd by Mr. Fydenkevez. Roll call vote: Bergeron-yes, Pierce-yes, Fydenkevez-yes. Reconvened in open session at 6:40pm. Motion to recess until 7:00pm by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 3-0.
- Reconvened at 7:07pm.
- Moment in History -Mr. Fydenkevez read excerpt from 1919 Annual Town Report about the educational importance of children's nutrition.
- Mr. Bergeron gave an overview of the agenda.
- Joint meeting with Town of Leverett on shared Fire Services Leverett attendees: Board of Selectmen; Town Administrator; Fire Department Study Committee-Judy Weinthaler, Chair; and Deputy Fire Chief Stuart Olson. Ms. Weinthaler gave an overview of Leverett's Fire Department study. Three of Leverett Fire Department's key staff are nearing retirement; considerations with regard to cooperative staffing, apparatus, training, etc. Mr. Fydenkevez-overview of SCEMS. Apparatus is expensive-makes sense to discuss. Discussion regarding ideas and goals. Rich Brazeau, Leverett Selectboard-problems recruiting and maintaining staff. Strong Chief in Leverett, retirements of senior staff with in year. Study committee brought forward suggestion for full-time day position. Would like to get conversation going on cooperation. Maybe share Chief or full-time staff. Chief Ahearn-full-time fighter does inspections during day, issues burn permits. Discussion regarding emergency management, administrative work, shelter/emergency preparedness. Starting point to discussion-sharing position. Mr. Olson-important to have even a single responder for triage. Current LFD staffing level-one part-time Chief and all call force. Discussion regarding long-term sustainability. Chief Ahearn-currently 12-15 active on Sunderland roster. Next stepslook at shared full-time skill set; response times by geography. Leverett active call roster about 10 currently. Discussion regarding job description; administrative chief and operations chief; spreading out (scheduling) to provide more coverage. Chief Ahearn would be interesting in exploring shared firefighter position. Mr. Pierce-nature of calls and time of fires or incidents can't be predicted. Discussion regarding trainings. Mr. Fydenkevez-with more people, better training may be able to happen to expand capabilities. Mr. Olson-cautions that increased fire response could create burnout. Need to be careful about asking call force to do more. Leverett and Shutesbury have automatic mutual aid for certain incidents. Discussion regarding focusing on shared person to help meet coverage need. Peter d'Errico, Leverett Selectboard-need to consider both administrative needs and operations needs with shared position. Next steps-Put together working group of those directly involved to identify path forward. Goals-define what we want; commonalities; exchange ideas; identify needs. Mr. Bergeron-Sunderland to identify 2 or 3 names for working group. Leverett will do the same. Ms. Weinthaler-Leverett Chief is retiring in January. Mr. Fydenkevez-suggest Leverett write up goals and timeline. Sunderland willing to discuss all ideas on the table. Ms. Weinthaler-need to keep long-range operations/sustainability in sight. Mr. Pierce-need to understand moving forward as individual towns isn't sustainable. Mr. Fydenkevez-partnerships can work but all parties need equal say. Ms. Weinthaler-need to consider cost considerations for fire service. Mr. Fydenkevez-cannot replicate existing call service with less money. Week of April 28th-bring names forward for working group. Identify short term goals and next steps.
