- July 31, 2014 Minutes Motion by Mr. Pierce to accept the minutes for July 31, 2014, 2nd by Mr. Fydenkevez. Vote 2-0.
- Board Updates Mr. Fydenkevez reported the South County Senior Center is thriving.
- Town Administrator Updates Ms. Nartowicz gave an update on the proposed 120 North Main Street property acquisition. Public Forum to be held Monday, August 18th at 6:30 p.m. Mr. Fydenkevezneed Town Meeting timeline and financing information for public forum. Town's FY13 audit has been completed, including triennial OPEB report. Awaiting draft management letter and financial statements. Mr. Fydenkevez-need list of all users of ballfields from Recreation. Set up meeting with Recreation Committee to discuss scheduling of fields. Piles of dirt from the Merritt Field project at the elementary school need to be hauled away and the area cleared before school starts.
- Cultural Council Appointment Recommendation read by Mr. Pierce. Motion to appoint Tammy Thompson to the Cultural Council for a 3-year term expiring August 10, 2017, 2nd by Mr. Fydenkevez. Vote 2-0.
- Election Officer Appointments Slate (attached) read by Mr. Pierce. Motion to appoint by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- Declaration of Surplus Property Motion to declare the 1999 F350 Highway truck with Fisher 9 ft. minute-mount plow surplus, for disposition (estimated value \$3,000-\$5,000) by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- ZBA Resignation Motion to accept with regret the resignation of Thomas Herrick from ZBA by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- CPA Determination of Eligibility 120 North Main Street Property Acquisition. Motion to approve the Board of Selectmen as the project applicant by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
- One-day Liquor License Application Sheila Heady, applicant for Town Park event. Ms. Heady stated that there will be a free bar for service, but no alcohol will be sold. Special one-day license applies only to sales of alcoholic beverages. Town will refund \$100 application fee to Ms. Heady, and will clarify on policy and application, the applicability to sales only.
- Sewer Connection Application Osterman Propane, LLC, 339 Amherst Rd. Sewer line to cross Rt. 116. MassDOT approved permit for the Town (the "Grantee") to do the work in the state highway layout. Mr. Fydenkevez-Permit implies that Town takes all responsibility for private project. Osterman is currently on septic system. Building renovations require reconstructing the septic system or hooking into Town sewer. Installed line will be approx. 400 ft., 2-in. forced main with pump. Mr. Fydenkevez-How will the pitch and jet rodding be accommodated per the plans? What is the invert elevation to manhole, and at what angle will the pipe be positioned in the manhole? Will a macerator be used prior to pumping? Recommends Rich Brynda look at best connection to manhole. Reviewed MassDOT permit. Mr. Fydenkevez-Board will continue discussion at meeting next Monday. Will reference stipulations in prior sewer connection permits for this and future connection applications.
- Motion to adjourn by Mr. Pierce, 2nd by Mr. Fydenkevez. Vote 2-0.
