- December 22, 2014 Minutes Tabled to next Monday.
- Board of Selectmen Updates Mr. Bergeron-120 North Main Street meeting this Thursday. Site studies RFP being developed. Should be finalized soon. Committee members have done research on projects of similar size to Sunderland's vision. Mr. Pierce-Comcast negotiations extension to March 7<sup>th</sup>. Meeting was held Saturday. Move to approve extension of Comcast negotiations to March 7, 2015 by Mr. Bergeron, 2<sup>nd</sup> by Mr. Pierce. Vote 2-0.
- Town Administrator Update Heating oil prices are the lowest they've been since 2009. Recommend that the Board authorize Procurement Officer to lock in FY16 fixed rate while rates are low. Doing this would help with FY16 budget planning and would offset some of the electricity cost increase. Motion by Mr. Bergeron to authorize Ms. Nartowicz to lock in fixed heating oil rate for FY16, 2<sup>nd</sup> by Mr. Pierce. Vote 2-0.
- PEG Access Funding Motion by Mr. Bergeron to transfer from PEG Access \$1,803.86 to pay FCAT for upgrades to Town Office building equipment, 2<sup>nd</sup> Mr. Pierce. Vote 2-0.
- Senior Tax Work-Off Procedures Amendments Motion by Mr. Bergeron to amend procedures per 2015 state minimum wage change to \$9.00, 2<sup>nd</sup> by Mr. Pierce. Vote 2-0.
- Owner's Agent Technical Assistance Contract Beacon Integrated Solutions to provide expert assistance to
  the Town in resuming municipal solar projects. Motion by Mr. Bergeron to enter into OATA contract with
  Beacon Integrated Solutions, LLC, state contract #DCP-0711-EX1, 2<sup>nd</sup> by Mr. Pierce. Vote 2-0. Board of
  Selectmen designee for solar project working group-Mr. Bergeron nominated Mr. Pierce. Mr. Pierce is
  willing to serve as Board's designee. Kick-off meeting will be held Jan. 20<sup>th</sup> or 21<sup>st</sup> with Beth Greenblatt to
  discuss solar market updates and next steps.
