Selectmen Updates

- Mr. Pierce noted there was a Personnel Committee meeting scheduled for April 5, 2016.

- Thank you to the individuals that organized the surprise retirement party for Chief Gilbert on Saturday. It was a very nice event with many presentations including those from Senator Rosenberg, Representative Kulik, Franklin County Police Chiefs Association and Western Mass Police Chiefs Association and a special presentation on behalf of event attendees.
- Mr. Fydenkevez also reported on the Franklin County Selectmens Association that was held the
 previous week at Chandler's Restaurant. The guest speaker was the Secretary of Economic
 Development. Some notable items that were addressed was rail service along the upper section of
 Route 2 and education expectations related to Chapter 70 and Charter Schools. The state is supportive
 of education funding and increases but will not continue to increase funding if they are not seeing
 results or changes they want in education.
- In speaking with Sen. Rosenberg and Rep. Kulik recently, they have reported working with the current Baker administration has been very good and effective.
- The informational meeting regarding the South County EMS was held March 31. It was very well attended and a lot of good questions were asked. It was felt there was an overall support for the service from the audience.
