The Public Hearing was opened at 7:45pm. M. Briggs read the hearing notice as it appeared in the Millbury Sutton Chronicle.

The project consists of repair of an existing dock.

M. Briggs reviewed the site visit notes. After seeing the new dock, Mr. Klama was told that he didn't have to appear at the next meeting, but should send us proof that the wood that he built the new dock with was suitable for the water and purchased after the 2004 bylaw that the wood no longer contains arsenic. The secretary explained that Mr. Boutiette sent information about the wood that they were referring to, about the removal of all chemicals and the arsenic making it suitable to use in the lakes and ponds.

The continuation was opened at 8:00pm. J. Smith read the hearing notice as it appeared in the Millbury Sutton Chronicle.

The project consists of surface water withdrawal from wetland/pond to augment irrigation of golf course on an emergency basis only.

Present: Donald Provencher, Provencher Engineering, LLC, Michael Gordon, owner This was continued, with the applicant's permission, to September 19, 2012

M. Briggs said that he had a conversation with Mr. Gordon and told him that his Emergency Certificate would expire as of this meeting. If there was need for more pumping, he was to contact the Commission so that they could acknowledge the fact that he is back in the area working. Mr. Briggs also did a site visit and saw where the actual out flow of the pond is. He thinks that most of the water is coming through the whole dam structure, enough so that there is a defined channel below it that forms the stream. This seems to be the major contributor of the stream that winds up at the Manchaug Water Treatment Plant on Putnam Hill Road. He spoke to B. Kickham at DEP. The Commission is waiting to hear from results of the testing for fish from this pond to determine if this is a vernal pool. This would then determine if Mr. Gordon would be able to withdraw the 100,000 gallons a day.

Mr. Gordon is going to pull the pumps out of the wells to see if there is something wrong with the pumps that he currently has. He has also drilled another well which is not on line yet. DEP has recommended that as part of the Order of Conditions, that he not, take more than two inches of water from the pond, regardless of the 100,000 gallon allowance. Mr. Briggs feels that this pond is big enough that it could have a fish population.

The Emergency Certificate would not be extended. If they call the office tell them that they need to take pictures of the meter before and after, and that someone would be out to see them right away.

66 Wilderness Drive - M. Briggs explained that the Consultant went out on this site for a pre-construction meeting on October 13th. He read the report from Mr. Faneuf.

18 Eight Lots Road - M. Briggs explained that the Consultant did a site visit on this property and read the report he received from Mr. Faneuf. The Commission needs to send a letter saying they need to provide the Commission with a revised plan.

58 Main Street - The secretary explained this was an FYI. They need new abutter's notices for a Notice of Intent. The previous filing is under the new two year Government Extension Act to 2014.

124 Manchaug Road - the Board of Health has approved the septic plans. A. Aubin will do a site visit for the erosion controls inspection.

Tennessee Gas Pipeline Company - The secretary reviewed the information from the letter received from the Gas Company. The Commission needs to answer their request. A letter would go to the Tennessee Gas Company with the concerns of the wetland areas in question. They should notify Conservation once the work has been completed. They should then come in to let the Commission know there are no adverse or long term impacts to that wetland area.

Rules & Regs – a workshop would be on October 24, 2012 at 7:30pm to review for the Warrant in May of 2013. The secretary would find out when the deadline is for the May meeting.
