Present: Paul Hutnak, Andrews Survey, John Murray

- P. Hutnak explained the revised plans and past OOC intentions. The new owners want to amend the original order. The new plans add a detail showing a 40 x 30' temporary dock that the owner wants to add. He explained other changes and what the owner wants to do with the remaining site, and the additional plantings in general. They would be using clean crushed stones, not gravel, in the driveway. He has added a swale as part of the drainage feature which was not on the approved plan.
- M. Briggs said the Commission needs the Consultant do a scope of review and he will give a proposal for this review. He would also like to see the dock moved to the left from the beach area, away from the intermittent stream that empties into the lake. The details and spec sheet for the dock are needed for the records.
- B. Faneuf summarized from the original OOC, and said they need more details on the plantings to go forward.
- J. Sheehan said that they need to request to Amend the OOC so the Commission can vote on that. The plantings need to be put in as soon as possible and not leave them to the end of the project. Stop all other activity until the amendment has been approved.
