D. Heney updated the board using pictures taken of the work that was done on this driveway that he has been monitoring since last September in 2012. He asked if he could put in a 6" pipe at the crossing and put another pipe four feet away from that pipe.

M. Briggs suggested he replace the 6" pipe with an 8" pipe. A plan is also needed showing the pipe, the complete replication area, and replace the flags at the Replication area to be done.
