B. Faneuf summarized his site visit report using the revised plans. He wasn't sure, based on the plans, exactly what trees were being removed. He asked Mr. Anderson to make it more clear what trees were to be felled, and why it was necessary to remove them. A discussion of what trees and why they needed to be felled ensued. Mr. Faneuf went on to say that the Commission could approve the permit, contingent

upon the removal the trees talked about, provided they are clearly outlined on a revised plan. Mitigation for the felling of the trees could be offset via permanent eradication of invasive plants along the corridor of the intermittent stream from the pond all the way up to the road, and from the northern property line to the permanent limit of work. Also to note on the plan, show the split rail fence and the use of 12" wattles for the erosion controls.

This system is 100' from the neighbor's house and the well is in the roadway.
