Review and Approve Minutes:

Public forum: Members of the Sutton Historical Society. William Cobb of McClean Road presented to the Commission verbal plans for his offer to purchase an historic Mill property located at 44 Marble Rd. He explained his future goals with the Historic property and what he had for information pertaining to the historic value of the property to the town. He also exhibited an interest to have an information partnership with this commission as to guidance towards restoration and information regarding the Marble Village inventory and the future of this historic area. Donna Rossio informed the presenter she would assist in finding more information regarding the Marble Village District and it's inventory. Mr. Cobb also expressed to the board his Engineering background and how it may help with the restoration of the Water Mill located on the same property.

MHC Grant update: Donna Rossio and Wally Baker attended the 101 Grant Workshop meeting with the Town Planner. The process was outlined in a step by step process and the plans for updating of the present inventory were discussed. Our next deadline is July 2015 for the next step.

Canal Breech Update: Letters from Mass D.O.T. and P.A.L. (Public Archaeology Laboratory) both dated April 10 2015 were read by the present members. Wally Baker was present at several on site meetings and the members reviewed photos taken at the scene after restoration. All members present were in agreement that barring the situation, the final repair result was more than satisfactory. This board publicly thanked the town Boards and Departments involved with this project and feels it was handled very well with a positive out come that was achieved by teamwork.
