## **Youth Services Report**

#### Children's Services

- 1. Past Programs and Attendance Numbers:
- In July, we had 30 children's programs with a total of 557 people in attendance.
- In August, we had 26 children's programs with a total of 480 people in attendance.
  - 500+ people registered for Summer Reading.
- Participation certificates were given out Simonian and Elementary School last week.

#### 2. Adult Programs:

- a. The Photography program wrapped up strongly and with good feedback.
- b. The aromatherapy program was a smashing success. We will see about having her back in Feb./March for her chocolate program
- c. The ukulele program started last week it filled up with 10 adults which was the maximum capacity. The Grafton Library loaned their ukuleles so we were able to cover anyone who did not have their own.
- d. In July there were 5 adult programs with 43 participants. In the month of August we had 9 programs with a total of 51 participants.

#### 3. Friends Update:

a. The Friends have cancelled their wine tasting event because they were not able to get vendors to sign on.

#### 4. Staff:

a. Since the last meeting a new Page, Corrina Rossetti, was hired. Staffing has now settled into a normal rotation.

### 5. <u>LBNC:</u>

a. Meetings have been proceeding as scheduled. The Next meeting is this Wednesday at 7:00pm. The engineers should be performing perc tests on the two sites ASAP. The public information session is scheduled for Oct. 5 at 7:00pm. We need to go before the Finance and Warrant Advisory Committee next Tuesday at 6:30pm. (It was reported that the PERC tests will not be completed in time for the public info. Session or the Warrant committee meeting.)

### 6. <u>Misc.:</u>

- **a.** I finished the second annual report for the MBLC which is the financial report. Lisa signed it and it has been mailed.
- b. We've formed a formal coalition with 11 neighboring communities and are calling ourselves the 'Blackstone Valley Libraries'. Participants include: Sutton, Blackstone, Upton, Northbridge (Whitinsville), Douglas, uxbridge, Grafton, Mendon, Millbury, Hopedale, Millville and Mendon.
- c. I missed the first meeting due to scheduling issues here but the first two initiatives being tackled are museum passes and large print books. I've already said that we will participate in the 'floating' of adult large print materials. What this means is that when an adult large print book is returned to us

- from any of the participating libraries, we will keep it on our shelf until such point as it is checked out, put on hold, or recalled to its owning library. Details are still being worked out. (There was a brief discussion after which the Trustees agreed that Large Print Initiative is beneficial to our patrons.)
- d. The second initiative is museum pass sharing and I held off on jumping in until we talked about it.

  Basically, we would all cross promote our passes but they would not be reservable by residents of other towns just available on a walk-in "day of use" basis. (There were some questions then was discussion about this initiative but it was agreed that participation in museum pass sharing would be a good idea.)
