Sutton Plaza Extension – The Board reviewed correspondence from Goulston & Storrs on behalf of their client Centerpoint LLC requesting a one year extension of their Site Plan Approval, Route 146 Special Permit, and Groundwater Special Permit for the Sutton Plaza Expansion project. They noted as they had just recently received confirmation that Wilkinsonville Water would have their wells on like shortly, that they did not program construction of the Sutton location into their 2009 capital plans, therefore they will not be able to proceed with this store until at least next year. They added that of course the economy is not helping any of their expansion plans, but they have every intension of constructing this store in the near future.

The Board had concerns about rental being unrelated to the principal use, not allowing the accessory use designation. They requested the Planning Director ask the owner to appear at the next Board meeting.

Proposed Bylaw Changes - The Board discussed Town Counsels comments regarding the proposed bylaw changes for Spring Town Meeting. They agreed the wind turbine bylaw changes should be tabled until they can be dealt with comprehensively, hopefully for fall. They asked that size adjustments be added for illuminated and non-illuminated signs, and agreed to add clarification on banners requested by the Building Commissioner.
