This meeting began in joint session with the Sutton Zoning Board of Appeals (ZBA). The ZBA is acting on a request for a c. 40A, Section 6 Finding that the proposed expansion of the pre-existing non-conforming convenience store use is no more detrimental to the neighborhood that the existing use. If the ZBA acts favorably on their part of the application, the Planning Board will then consider the specifics of the Site Plan.

After the motion to grant the c. 40A Section 6 finding and close of the ZBA hearing on their portion of this application, the Planning Board moved to another meeting room to finish deliberation on the proposed renovations.

The applicant reviewed the Site Plan details with the Planning Board. Major changes included delineation and striping of parking spaces and interior changes.

The Board considered various waiver requests:

IV.B.5. Waiver to omit interior lot landscaping as only 9 parking spaces are required, even though 15+ are provided. The Board discussed which spaces need to be painted.

9 spaces are required and the applicant should not be penalized and forced to install site features

for a larger lot simply because he provides more beneficial parking, D. Moroney

3. Prior to occupancy of the expanded store, parking spaces 1-7 & 10-12 shall be lined out. Spaces 8, 9, and the employee spaces will not be lined unless it is found to be necessary. Spaces 8 & 9 may be striped and restricted for loading/unloading if necessary.

4. Any new signage shall be approved by the Planning Board prior to installation.
