Meeting opened for discussion at 7:08 pm.

II: Review of modular project status:

Information provided by Tim Alix (SBS). SBS has had meetings with Vanguard. The insurance is in process of being completed. Permits for groundwork and construction are nearing completion. Construction trailer is expected to be on site by 4/30/11, should be in use starting Monday, May 2. Target date for completion is 8/3/11. Discussion also included working on the utilities – SBS in process of getting a transformer on site with permanent power for testing as modular units arrive.

The dates for the filed sub-bids and general contractor bids have been pushed back to allow contractors more time to review and prepare proposals. The filed sub-bids are due 5/4/11. GC bids are due 5/19/11.

John Turner Consulting, Dover, NH (Local office Worcester, Ma.)

UTS of Massachusetts, Stoneham, Ma.

Professional Services Industries (PSI) Canton, Ma.

Both Briggs and John Turner were rated as advantageous.

Both UTS and PSI were rated highly advantageous.

After a question and answer period and following the recommendation by SBS to award the contract to UTS the following motion was made:

Motion to offer the contract to UTS was made by Roger Raymond, second by Mark Bailey. The committee voted 7-0-0 to award contract to UTS.

b. Move Services RFS – Tim Alix presented a synopsis.

We received bids for moving services from the following 3 companies:

ABC Moving and Storage, Diamond Relocation, Tobin Scientific

A lengthy discussion regarding the significant differences in the bid pricing followed. Both SBS and Flansburgh offered assurances that sufficient protections were in place for our project and advised that the committee award the contract to the low bidder, ABC Moving and Storage. SBS had vetted each company and had received high recommendations for ABC.

Motion to award contract to ABC Moving and Storage by Donna Davis, second by Mark Bailey. Committee voted 7-0-0 to award contract to ABC Moving and Storage.
