Agenda Item 6 – Update on School Building Project

Ms. Wendy Mead, Chairperson, Sutton School Building Committee, and liaison to the School Committee, provided an update on the project. Numerous meetings took place over the summer and are continuing, including with the design team, the OPM, National Grid, and town and school administrators. Monthly reports are sent to the MSBA. The bidding process has begun. The project is coming together and is on target, in terms of the timeline. The district continues to search for ways to save money on the project. There have been some changes to the Building Committee, with Christine Watkins stepping down after six years, and Mark Bailey taking her place. In March and April, the athletic fields will be prepared for the modular units. There will be considerable construction activity, beginning in the spring. As much as possible will be done in a way to minimize the disruption to the students. It will likely take two full summers for building, and a third summer for preparation for occupancy. The final design will be unveiled to the community when it is available and before ground is broken on the project. The cost of furniture, fixtures and equipment is included in the total cost of the project.

Agenda Item 9 – Superintendent's Update

- > The start of school went very well and it is great to have the students and their excitement back in the buildings.
- To improve supervision of the middle and high school students that remain at school after classes end, and to allow students access to the library and to the computers in the library, the library will

- remain open from 2:00 until 3:30. There is also discussion with Dan Delongchamp, Athletic Director, to develop a program to allow for better supervision of the student athletes who remain at school between the end of classes and the beginning of athletic practice.
- The existing busing system is an area of concern; the fiscal reality of what the district can afford for buses (even given that families pay to use the bus), the time that it takes the buses to pick up the students and get to school, and safety concerns about where the buses stop to pick up students, and the safety of the roads on which the students must walk some distance to get to the bus stop. This entire system will be reviewed extensively, and hopefully resolved, over the next several weeks.
- > Budget review will become part of the regular meeting schedule.

Agenda Item 10 – New Business, Agenda Items, Action Items

- ➤ On September 7th, there will be a joint meeting with the Board of Selectmen (BOS) and the School Committee, at which, the BOS will appoint a new member to replace Tracey Zuliani, who is no longer on the Committee.
- ➤ The Policy Manual will be an Agenda Item at the next meeting School Committee meeting, on September 13.
