## Agenda Item 13 - Superintendent's Update

PARRC Assessment assignments have been completed. Testing will be done in two classes in grades 3,5 ( $6,7,8$ math) and high school geometry. SEPAC will be holding a fundraiser at Celtics game this Sunday. PAC sold over 100 tickets. We have 40 volunteers to sell $50 / 50$ raffle tickets. Mr. Friend will be selling tickets and it is rumored that he will be on the court at half time. A lock down drill was conducted today. It went very well and included a half dozen police, four members of the consulting firm for security and two EMTs, as well as Administration. Additional drills will be conducted throughout the spring. On February 4th, Mr. Friend will be attending a RETELL meeting, which is for school districts that have very few ELL students. The Virtual Middle School had 25 students participate this fall; every student had an average above $90 \%$. Jason Dimmick and Olivia Reinold both placed sixth this weekend at the Reggie Lewis Center Elite Track and Field Meet.
