#### Agenda Item 6 – Cafeteria Update

Michelle Babin reviewed some of the changes that were implemented in Food Services, which included: revamping and increasing the middle school and high school grab n'go lunch selections; offering a variety of wraps, salads and subs that are made fresh daily; increasing the variety and amount of fresh produce; and introducing scratch cooking and batch cooking. Ms. Babin has collaborated with the High School Special Education Department to have four of their students work in the high school kitchen on a daily basis. Ms. Babin received her BS in Culinary Nutrition from Johnson and Wales University and pursued her Registered Dietician through Meredith College.

Mr. Friend provided the Committee with an update of this year's budget. Although we are in very good shape, it is important to note that we do have a tight budget and there is not a lot of pocket money for an emergency situation. We do not anticipate overspending the budget.

#### Agenda Item 10 – Superintendent's Update

Mr. Friend extended a thank you to Jim Smith, Tim Harrison and FINCOM for their support of the new Math Series Investigations for grades K-5. The cost for the Math Series will be placed on the Capital Plan. Mr. Friend also thanked Denielle Staca and Tim Frasier, two middle school teachers, for their work on flipping classrooms. Ms. Staca created a videoconference to correct a student's open response. For homework, the student is instructed to watch the video and make suggested changes to improve his/her grade. The student's parents may also view the video. This type of homework allows for more challenging activities to be done while in the classroom. Our intention is to build upon this technological instructional strategy going forward. The Celtics fundraiser was a hit. Thanks to David Lyman, a special education teacher in the high school, who escorted the students on the bus and was a big seller of raffle tickets. We sold over \$5,600 and received \$2,800 for special education. Art teacher, Mrs. Hehir, has created online portfolios for each student in grades 1-5. Students and parents may sign on to view their portfolio.

Parents of high school students received a great letter from Principal, Ted McCarthy, regarding drug and alcohol abuse. As safety is paramount to the school system, our job is to educate the students in this regard.
