Notice is hereby given in accordance with Article II, Section 2, of the Bylaws of the Town of Swampscott that a Special Town Meeting will be held on Monday, November 14, 2016, beginning at 7:00 p.m. at Swampscott High School, 200 Essex Street, Swampscott, Massachusetts.

Moderator Michael McClung, will preside.

Meeting Certifications:

I hereby certify that in accordance with the adjournment of the Special Town Meeting of November 14, 2016 was held in the Swampscott High School auditorium located at 200 Essex Street, Swampscott. The meeting was called to order at 7:15 p.m. with the necessary quorum being present (199). At 8:40 p.m. it was voted to adjourn & dissolve the November 23, 2015 Special Town Meeting.

Attendance:

For the November 14, 2016 Special Town Meeting attendance, by precinct, see the list of members at the end of this report.

ARTICLE 1. To hear and act on the reports of Town Officials, Boards and Committees.

To accept a report from Board of Selectmen Chair Dreeben who began with a statement that it's a time of transition locally and nationally. Ms. Dreeben then gave an update on the Town Administrator search, the budget process and ongoing town initiatives.

To accept a report from school Superintendent Pamela Angelakis with a Fy11 thru FY18 School budget report.

To accept a report from Commission on Disability members Nico Flannery-Pitcher, Jim Badger and Sam Paster with a PowerPoint presentation of the Commissions mission.

ARTICLE 2. Voted that the Town amend the FY17 budget voted under Article 10 of the May 2, 2016 Annual Town Meeting Warrant to raise and appropriate an additional \$408,587, and to increase Line No. 57, Rubbish and Recyclables Collections, from \$898,000 to \$1,013,000 and to increase Line No. 82, from \$4,226,939 to \$4520,526 (Maturing Debt Budget, Principal, from \$3,356,152 to \$3,595,761, and Interest, from \$770,787 to \$824,765), or take any other action relative thereto.

Sponsored by the Town Administrator/Town Accountant

Comment: This article will fund increased budget items that occurred after the FY17 Budget was adopted in May 2016.

Article 2. That this article is approved. Unanimous Vote/Passed 11/14/16 STM ARTICLE 3. Voted that the Town appropriate the sum of \$2,000,000 for the purpose of funding design and construction costs, including any incidental or related costs, to eliminate non-storm water pollutants from entering the Town's drainage system; and to fund said appropriation, to authorize the Treasurer, with the approval of the Board of Selectmen, to borrow said sum pursuant to G.L. c.44, §§7 or 8 or any other enabling authority and issue bonds or notes of the Town therefor, and to authorize the Town to apply for, accept and expend any federal or state grants or loans that may be available for the project, or take any action relative thereto.

Sponsored by the Town Administrator

Comment: This article will keep the Town in compliance with the EPA Consent Decree that requires the Town to eliminate non-storm water pollutants from entering the Town's drainage system. In June 2016, the Town submitted a plan to the EPA to complete the first phase of construction work in 2017.

Capital Improvements Committee Chair Dan Eccles stated the Capital Improvement's Committee voted unanimously in support of this article.

Article 3. That this article is approved.
Unanimous Vote/Passed
11/14/16 STM

ARTICLE 4. Voted that the Town raise and appropriate the sum of \$128,750 for the purpose of funding the cost of planning and designing coastal resiliency improvements at the beach access ways in Town, including any incidental or related costs, the expenditure of said sum shall be contingent upon the town's receipt of a reimbursement grant from CZM in the amount of \$103,000.

Sponsored by the Town Administrator

Comment: The Town recently was awarded a \$103,000 reimbursement grant from Coastal Zone Management. The grant requires a 25% matching contribution from the Town, either in cash or with in-kind services. Because the grant monies are provided on a reimbursement basis, the Town must appropriate the funds for the entire project cost at Town Meeting prior to starting the work. The CZM program requires design to be completed by June 30, 2017. Therefore, the Town would risk losing the grant if it does not appropriate funds this fall at Special Town Meeting. Financial request — option A (\$103,000 w/ Town to provide in-kind services) or option B (\$103,000 + 25% match of \$25,750 for total of \$128,750).

Article 4. That this article is approved as Amended. Motion Carries/Passed 11/14/16 STM

ARTICLE 5. Voted that the Town raise and appropriate the sum of **\$91,554** to reimburse the State Retirement Board for the overpayment of cost of living adjustments ("COLA") for Non-Contributory Retirees; or to take any other action relative thereto

Sponsored by the Town Administrator

Comment: This article will allow the Town to reimburse the State Retirement Board for an overpayment of cost of living adjustments ("COLA") for Non-Contributory Retirees, which has occurred over the past 20 years. This will be the final payment.

Article 5. That this article is approved. Motion Carries/Passed 11/14/16 STM

ARTICLE 6. Voted that the Town raise and appropriate the sum of \$35,000 to purchase the remaining National Grid Streetlight Poles and Fixtures; or take any other action relative thereto.

Sponsored by the Board of Selectmen

Comment: This article will allow the Town to purchase 63 poles/68 lights that National Grid still owns in Town. Swampscott has paid a "facility charge" (essentially a leasing fee) for the poles and lights over the past 12 months of \$21,366. That facility charge will not exist once we own the remaining streetlights.

Article 6. That this article is approved. Motion Carries/Passed 11/14/16 STM

ARTICLE 7. Voted that the Town amend the General By-Laws "Article IX: Uses of Land – Section 7: Local Historic District" by deleting the text shown in strikethrough below, or take any other action related thereto.

Sponsored by the Historic District Commission

Comment: Massachusetts General Laws Chapter 40C (which pertains to Local Historic Districts) does not require the publishing of the notice in a newspaper. In order to reduce the burden on property owners, the Historic District Commission would like to remove the newspaper ad requirement from our local bylaw. Posting of the notice/agenda as well as abutter notification will still occur.

G. Procedures for Review of Applications

(4) If the COMMISSION determines that such application involves any EXTERIOR ARCHITECTURAL FEATURE subject to review under this By-law, it shall hold a public hearing on the application, except as may otherwise be provided in this By-law. The COMMISSION shall hold such a public hearing within forty-five (45) days from the date of the filing of the application. At least fourteen (14) days before said public hearing, public notice shall be given by posting in a conspicuous place at Town Hall—and—in a newspaper of general circulation—in Swampscott. Such notice shall identify the time, place and purpose of the public hearing. Concurrently, a copy of said public notice shall be mailed to the applicant, to the owner of the property under consideration if different from applicant, to the owners of all adjoining properties and of other properties deemed

by the COMMISSION to be materially affected thereby, all as they appear on the most recent applicable tax list, to the Planning Board, to any person filing a written request for notice of hearings, such request to be renewed yearly in December, and to such other persons as the COMMISSION shall deem entitled to notice.

J. Categorical Approval

The COMMISSION may determine from time to time after a public hearing, duly advertised and posted at least fourteen (14) days in advance in a conspicuous place at Town Hall—and in a newspaper of general circulation—in—Swampscott, that certain categories of EXTERIOR ARCHITECTURAL FEATURES, STRUCTURES or BUILDING under certain conditions may be CONSTRUCTED or ALTERED without review by the COMMISSION without causing substantial derogation from the intent and purpose of this By-law.

Pursuant to G.L. c.40C, §3, a 2/3 vote is required to approve Article 6 and a recommendation must be made by the Historic District Commission or 60 days shall have lapsed since the article was submitted to the HDC without a recommendation. For your convenience, I have attached Form 8, which outlines the requirements for approval of a historic district bylaw, for your review and information. This is a form that the Town Clerk is required to complete and send to the Attorney General following Town Meeting as part of the AG's approval of a Historic District bylaw amendment.

Article 7. That this article is approved. Unanimous Vote/Passed 11/14/16 STM **ARTICLE 8. Voted** that the Town amend General By-laws, Article V, Streets and Sidewalks, Section 16, Vehicle Parking, Private Ways and Property, by inserting the text shown in bold below and deleting the text shown in strikethrough below, or take any other action relative thereto.

Sponsored by the Town Administrator/Police Department

Comment: This will allow the police to issue handicap parking tickets on Private Property.

SECTION 16. VEHICLE PARKING, PRIVATE WAYS AND PROPERTY

- (a) It shall be unlawful to obstruct or park a vehicle so as to block a private way from access for fire apparatus to any building.
- (b) It shall be unlawful to obstruct or park a vehicle in any fire lane hereby established and adopted as part of the Town of Swampscott Fire Prevention Code, Section 28.16, said fire lane to be a distance of not less than twenty (20) feet from the curbing of a sidewalk in a shopping center, theater, residential complex, health center, school, and public buildings or similar locations, said lanes to be marked at said locations.
- (c) It shall be unlawful to obstruct or park a vehicle in any parking space designated as reserved for vehicles owned and operated by disabled veterans or handicapped persons.
- (e d) Any object or vehicle blocking or so parked as to obstruct any fire lane, any parking space reserved or designated for disabled veterans or handicapped persons, or any private way in violation of Section (a), er-(b) or (c) of this by-law may be removed or towed by the town at the expense of the owner and without liability to the town.
- (d e) Any person whether he be the owner or operator of any vehicle involved in a violation of either Section (a), or (b) or (c) of this by-law and for being found guilty by a court having jurisdiction thereof shall be subject to the fine established by the Board of Selectmen pursuant to Massachusetts General Laws.
- (e f) Subject to established parking regulations, overnight parking of registered motor vehicles is permitted on all public roads at any time during the year, and overnight parking is permitted in designated off-street public parking areas, but only in accordance with rules to accommodate day-time uses of said off-street parking areas. Except that, any permitted parking may be prohibited in accordance with other provisions of these bylaws, when necessary to allow fire and police personnel to carry out their lawful duties; and, during declared snow events.

A snow event is declared when blue lights located throughout the town on street poles are blinking; when notification is sent to all households through the town's automatic telephone call system; and/or when official announcements are made through major media outlets. The town may remove any vehicle impeding snow removal in accordance with Article V, Section 5 of these bylaws.

Article 8. That this article is approved. Motion Carries/Passed 11/14/16 STM
