The meeting was called to order at 7:00 pm with the necessary quorum being present. At 7:02 pm it was voted dissolve the November 18, 2013 Special Town Meeting.

ARTICLE 1 To hear and act on the reports of Town Officials, Boards and Committees.

Joe Crimmins, Swampscott School Building Committee Chair reported an update of the new Elementary School project.

Mary DeChillo, Local Historic District Study Committee Chair reported a work update the committee has completed thus far along with an outline of work the committee needs to do in the upcoming months.

Neal Duffy, Renewable Energy Committee Chair reported highlights the committee has been up to along with a brief overview of some of the initiatives the committee will be moving forward in the next year or two.

ARTICLE 2 To see if the Town amend the FY14 budget voted under Article 21 of the May 6, 2013 Annual Town Meeting warrant to increase under Line No. 82 Veteran Services from \$6,500 to \$41,500, and increase under Line No. 32 Pension Contribution from \$3,841,097 to \$4,050,402, within Line No. 67 (Sewer) Pension from \$128,254 to \$135,560 and Line No. 71 (Water) Pension from \$141,797 to \$149,874 and by raise and appropriating, borrowing or transferring from available funds, or act or to take any action relative thereto.

Voted Article 2. That the Town amend the FY14 budget voted under Article 21 of the May 6, 2013 Annual Town Meeting warrant to increase under Line No. 82 Veteran Services from \$6,500 to \$41,500, and increase under Line No. 32 Pension Contribution from \$3,841,097 to \$4,050,402, within Line No. 67 (Sewer) Pension from \$128,254 to \$135,560 and Line No. 71 (Water) Pension from \$141,797 to \$149,874 and by raising and appropriating an additional \$244, 305 and furthermore by increasing the Sewer budget by \$7,306 paid from sewer revenue and increasing the water budget by \$8,077 paid by the water revenue.

ARTICLE 3 To see if the Town will vote to authorize the Board of Selectmen to acquire by gift, purchase, eminent domain or otherwise, for general municipal purposes, all or any portion or any interest in the property identified on Swampscott Assessor's Map 33, Lots 53, 10 and 10D abutting Ocean Avenue of 3.7+/- acres of undeveloped land and to raise and appropriate the sum of \$151,000 for this purpose and any costs and expenses related thereto, or take any other action relative thereto.

Voted Article 3. That the Town will vote to authorize the Board of Selectmen to acquire by gift, purchase, eminent domain or otherwise, for general municipal purposes, all or any portion or any interest in the property identified on Swampscott Assessor's Map 33, Lots 53, 10 and 10D abutting Ocean Avenue of 3.7+/- acres of undeveloped land and to raise and appropriate the sum of \$151,000 for this purpose and any costs and expenses related thereto, or take any other action relative thereto.

ARTICLE 4 To see if the Town will vote to raise and appropriate, transfer from available funds or borrow the sum of \$820,000 for a Department of Public Works Project Phase 1 of the Paradise Road Drainage Repair Project; or to take any other action relative thereto.

Voted Article 4. That the Town appropriates the sum of \$820,000 for the purpose of funding Phase 1 of the Paradise Road Drainage Repair Project, including any costs incidental or related thereto; that to meet this appropriation the Treasurer with the approval of the Board of Selectmen is authorized to borrow \$820,000 under G.L. c.44, \$7(1) or any other enabling authority.

ARTICLE 5 To see if the Town will vote to raise and appropriate, transfer from available funds or borrow a sum of money for a Department of Public Works town wide drainage study; or to take any other action relative thereto.

Voted Article 5. That the Town appropriates the sum of \$350,000 transfer from free cash for a Department of Public Works town wide drainage study.

ARTICLE 6 To see if the Town will vote to appropriate or transfer the sum of \$16,188.79 to the account of unpaid bills for the purpose of settling all bill contracted prior to July 1, 2013, and remaining unpaid at the time of closing the Town's books for the year ending June 30, 2013, according to the Town Accountant, or to take any other action relative thereto.

Voted Article 6. That the Town appropriates the sum of \$13, 969.21from free cash to the account of unpaid bills for the purpose of settling all bill contracted prior to July 1, 2013, and remaining unpaid at the time of closing the Town's books for the year ending June 30, 2013, according to the Town Accountant.

ARTICLE 7 To see if the Town will vote to appropriate the sum of \$1,541,073 to be expended by the Town Administrator for the cost of constructing a multi-sport, artificial turf field, demolish existing grandstands and replace the same with foundations for future grandstands, install footings and electrical conduit for future light towers, erect and/or install related fixtures and landscaping at Blocksidge Field in Phillips Park, together with all necessary work incidental thereto, including design and engineering, and including the payment of all costs incidental and relating thereto and to determine whether such amount should be raised by taxation, by transfer from available funds, by borrowing pursuant to Chapter 44, Section 7(25), Section 8(C) and Section 12(a) of the Massachusetts General Laws, or pursuant to any other enabling authority, and to issue bonds or notes or by any combination of the foregoing, and to dedicate Phillips Park, including Blocksidge Field, permanently for recreation purposes pursuant to Chapter 45, Section 14 of the Massachusetts General Laws, and further the Town Administrator is authorized to seek reimbursement under the Massachusetts Division of Conservation Services PARC Grant Program and enter into all necessary agreements relating to the PARC Grant Program or take any action relative thereto.
