The meeting was called to order at 7:10 p.m. with the necessary quorum being present (174). At 8:00 p.m. it was voted to adjourn & dissolve the November 23, 2015 Special Town Meeting.

ARTICLE 1. To hear and act on the reports of Town Officials, Boards and Committees.

Sponsored by the Board of Selectmen

Comment: This routine Article appears every year to allow Town groups to make reports.

- To accept the report from Board of Selectmen Chair Dreeben with a summary of the what the Board of Selectmen's has been working on in terms of infrastructure, buildings and processes since last Spring.
- To accept the report from DPW Director Gino Cresta and Precinct 1 Town Meeting Member who introduced Dave Peterson the Town's waste water consultant. The Town was hit with a decent decree from the EPA earlier this year. Mr. Peterson explains how the Town got to this point and what the Town will do going forward to comply with the decree.
- To accept the report from Planning Board Chair, Town Meeting Member and Chair of the Master Plan Committee regarding the Town's Master Plan.
- To accept the report from Patrick Jones Precinct 2 Town Meeting Member and a AllBlue Foundation Member with an update on the new multisport Turf Field at Blocksidge Field in Phillips Park.

ARTICLE 2. To see if the Town will vote to amend the FY16 budget voted under Article 25 of the May 4, 2015 Annual Town Meeting warrant to increase under Line No. 90, Reserve Fund, from \$175,000 to \$275,000 and reduce Line No. 98, Reg. Vocational School, from \$600,000 to \$500,000.

Sponsored by the Town Administrator

Comment: The final assessment for the regional school was lower than originally budgeted. This article will transfer funds to the Reserve Fund for any unforeseen or extraordinary costs that may occur during FY16.

Voted Article 2: That this Article is Approved Unanimous Vote/Passed 11/23/15 STM

ARTICLE 3. To see if the Town will vote to amend the FY16 Budget voted under Article 25 of the May 4, 2015 Annual Town Meeting Warrant to increase under Line No. 17, Technology Expenses, for a necessary Munis Upgrade and to raise and appropriate the sum of \$90,000; or to take any other action relative thereto.

Sponsored by the Town Administrator

Comment: This is a necessary upgrade in order to issue 2015 W-2's and 1099's and also to comply with the Health Care Reform Act.

Voted Article 3: That this Article is Approved Unanimous Vote/Passed 11/23/15 STM

ARTICLE 4. To see if the Town will vote to raise and appropriate the sum of \$45,000 for the purpose of funding a Facilities Coordinator Director Position for 6 months; or to take any other action relative thereto.

Sponsored by the Board of Selectmen and the School Committee

Comment: These funds from this article will allow the Town and School to hire a Facilities Coordinator this Fiscal Year.

Voted Article 4: That this Article is Approved Unanimous Vote as Amended/Passed 11/23/15 STM

ARTICLE 5. To see if the Town will vote to raise and appropriate the sum of \$30,000 to reimburse the State Retirement Board for the overpayment of Non-Contributory Retirees COLA; or to take any other action relative thereto.

Sponsored by the Town Administrator

Comment: This article will allow the town to reimburse the State Retirement Board for an overpayment of Non-Contrib. Retiree's COLA's over the last 20 years. This will be the first installment. The total amount due is \$113,422.67.

Voted Article 5: That this Article is Approved Unanimous Vote/Passed 11/23/15 STM

ARTICLE 6. To see if the Town will vote to amend the FY16 Budget voted under Article 25 of the May 4, 2015 Annual Town Meeting Warrant to increase under Line No. 90, Reserve Fund, and to raise and appropriate the additional sum of \$150,000; or to take any other action relative thereto.

Sponsored by the Town Administrator

Comment: This article will increase the Reserve Fund another \$150,000 for any unforeseen or extraordinary costs that may occur during FY16.

Voted Article 6: That this Article is Approved Unanimous Vote/Passed 11/23/15 STM

ARTICLE 7. To see if the Town will vote to raise and appropriate the sum of \$20,000 to pay for a regionalization study; or to take any other action relative thereto.

Comment: This will allow the town to pay for a study researching regionalization.
