# PETITION 16-29

#### 14 BAY VIEW DRIVE

Application of KENNETH SHUTZER o/b/o STEVEN P. BANKS seeking a special permit (nonconforming use/structure), dimensional special permit, and dimensional variance to rebuild a single-family residence replacing a structure destroyed by fire on a nonconforming lot. Map 20, Lot 141. *Continued from November meeting* 

M. Kornitsky calls forward Petition 16-29.

Attorney Kenneth Shutzer is present and explains he is representing the petitioner, Mr. Banks (who was not present). Attorney Shutzer stated to the Board that he is requesting to withdraw Petition 16-29 without prejudice.

MOTION : by M. Kornitsky, to grant a withdrawal for Petition 16-29 without prejudice, unanimously approved.

#### PETITION 16-38

# 36 EDGEHILL ROAD

This is an application by UBW Inc, to construct a single-family dwelling in an A2 district on an irregularly shaped lot containing less than the minimum lot size with less than required frontage.

Gary Finari, representing the petitioner UBW, Inc. was present.

Mr. Finari stated that he is asking for a continuance. Mr. Finari explained the council representing UBW, Inc (Attorney Samuel Vitali who was not present) was currently working on finalizing research on a certain deed as well as communicating with the Town Building Inspector.

<u>MOTION</u> : by M. Kornitsky to approve a request for continuance for Petition 16-38 to the March 28, 2017 hearing, seconded by A. Paprocki, unanimously approved.
