**Dear Michael:** 

The Halloween Committee, working in collaboration with the Recreation Dept, is planning for the 2014 Halloween Parade.

We have worked hard to build a parade that includes community participation, food, music, and entertainment that includes circus performers. The parade attracts people from all over to showcase our Village. I think we have succeeded in growing the parade every year.

We have been fortunate that the weather has cooperated and the restaurants that have participated have been able to serve food on the street. We are concerned that this may not always be the case, and it would make sense for us to set up a Tent in the parking lot next to the liquor store that would include food and drink.

We have solicited 2 locally brewed Hudson Valley beer distributors and 2 restaurants to participate. The total income from the tent will be \$4,000. This will help to offset some of the additional costs as we try to expand the parade to include more marching bands and more entertainment.

The tent will include.

- 2 beer distributors and 2 restaurants
- Police Constables acting as bouncers at the entrance to tent that will check ID's and make sure no one leaves the tent with beer.
- Tent opens when the DJ starts on Main Street and closes when the band ends. Appx 5 pm-9:30 pm

This should enhance the parade allowing people to grab something to eat and vendors a more comfortable and controlled space to serve.

We ask for Board approval to include a Food and Beer tent at the Halloween Block Party. If you need additional information, please let me know.
