<u>CONTINUATION OF PUBLIC HEARING – AMENDMENT TO THE SPECIAL</u> SETBACK PROVISIONS OF THE TARRYTOWN LAKES BUFFER ZONE LAW

Trustee Basher moved, seconded by Trustee Chillemi, and unanimously carried, that the hearing be opened.

Deputy Mayor Morabito questioned if anyone wished to address the Board. No one appeared.

Trustee Basher moved, seconded by Trustee Fixell, and unanimously carried, that the hearing be continued.

PUBLIC HEARING REGARDING AN AMENDMENT TO THE VILLAGE SITE DEVELOPMENT PLAN APPROVAL LAW

Attorney Shumejda read the following public notice:

PLEASE TAKE NOTICE that the Board of Trustees of the Village of Tarrytown will hold a public hearing on the 3rd day of January, 2005 at 8:00 p.m., in the Muncipal Building, 21 Wildey Street, Tarrytown, New York 10591, to hear, discuss and to act upon a proposed amendment to 5305-52 entitled "Site development plan approval" of the Code of the Village of Tarrytown. The complete text of the legislation is available at Village Hall. A descriptive summary of this legislation follows:

A LOCAL LAW to amend the Code of the Village of Tarrytown by amending §305-52 entitled "Site development plan approval."

SECTION 1. LEGISLATIVE INTENT AND FINDINGS OF FACT.

A. FINDINGS OF FACT.

The Village Board of the Village of Tarrytown has determined that the erection, enlargement, rehabilitation of all homes without site development plan approval by the Planning Board has the potential to threaten the health, safety and welfare, and quality of life in Tarrytown for the unique character of all neighborhoods in the villages rests upon the diversity in style and design of structures as well as the general uniformity in the scale of homes located on similarly sized lots in neighborhoods throughout the community.

B. Legislative Intent

It is the intention of the Board of Trustees of the Village of Tarrytown to mandate that applicants seeking the erection, enlargement, rehabilitation of all homes must obtain site development plan approval by the Planning Board.

SECTION 2. Amendment to Code §305-52 entitled "Site development plan approval"

(Changes are in bold, deletions are in parenthesis)

In accordance with § 7-725 of the Village Law, site development plan approval by the Planning Board shall be required for

- A. The erection, enlargement, rehabilitation, conversion, change of use that requires an increase in the minimum off-street parking requirements, change of occupancy or reuse of all buildings including new homes and additions to existing homes where the proposed addition increases the foot print of the existing home by 25% or more or results in a square footage or volume increase of 50% or more. (other than a single-family house constructed on a separate lot and not part of a subdivision on which significant land alteration is not required and alterations or additions to single-family and two-family house on which significant land alteration is not required. In all subdivisions), the Planning Board shall have the authority to review and approve site plans upon those proposed lots which it deems appropriate in the interest of the general welfare and to minimize any potential adverse impact. (For the purposes of this section, significant land alteration shall mean any alteration in a property's grade which could increase the height of a building as defined in §305-63 of the Zoning Code or any alteration to, or creation of, vehicular access to a public street.)
- B. All uses of land where no building is proposed, including the proposed use and development of all land within proposed subdivisions (of three or more lots, blocks, parcels or sites.)

(No other changes to Section)

SECTION 3. EFFECTIVE DATE

This Local Law shall take effect immediately, as provided by law. All interested parties are invited to attend and be heard. Access to the meeting room is available to the elderly and the handicapped. Signing is available for the hearing-impaired; a request must be made to the Village Clerk at least five days in advance of the meeting.

Trustee Sincero moved, seconded by Trustee Chillemi, and unanimously carried, that the hearing be opened.

Deputy Mayor Morabito questioned if anyone wished to address the Board. No one appeared.

REPORTS

Trustee Chillemi reported that when he learned of the Mayor holding the Village Holiday Party at Main Street Café, he had the following concerns and findings:

- The fact that the Mayor is holding the party there is fine if it is cost free to the Village. If not, then there's a problem concerning the Villages' code of ethics. He believes this would be a violation and therefore he would be against it.
- He is for a Holiday Party and would encourage the Senior Center be used as the location and that local caterers be used to supply the food. This way there is no conflict of interest.
- He stated that the Mayor informed Administrator McCabe that the Party would be at no cost to the Village but at his expense.
- He also stated that Trustee Basher brought to his attention two vouchers. No. 003899 in the amount of \$1,200 and voucher No. 003619 in the amount of \$1,624. These vouchers reflect services rendered by the Mayor's restaurant for the Village's Holiday Party for 2002 and 2003 totaling \$2,824. He recommends that Mayor Janos does right and fair and pays back the Village of Tarrytown the \$2,824.

Deputy Mayor Morabito stated the following:

- 1. He felt that it was unfair to bring this up when the Mayor was not present.
- 2. He questioned if Trustee Chillemi was on the Board in 2002 and 2003 and if he approved those vouchers at that time.

Trustee Chillemi responded that he was on the Board in 2002 and 2003 and that he did approve those vouchers and he believes it was an oversight.

Trustee Sincero reported that the Village calendars are finished and they will be in the mail very soon.

Deputy Mayor Morabito reported that the Neperan Road Park project will be discussed at the next work session with the restrictions that the Board agreed upon and will be voted on at the next January meeting. Cherbuliez Munz will have plans and we will hold public hearings to get the public's input on this project.

Trustee Fixell reminded the public that on Wednesday at 6:00 p.m. there will be a special meeting held at Village Hall to discuss the Final Environmental Impact Statement (FEIS)
