PRESENT: Mayor Fixell, presiding; Trustees Basher, Butler, Chillemi, Crucy Burkhardt, Pollack, and Zollo; Village Attorney Shumejda; Village Administrator McCabe; Village Treasurer Hart; Village Clerk Booth

<u>CONTINUATION OF PUBLIC HEARING – SPECIAL SETBACK PROVISIONS OF</u> THE TARRYOWN LAKES BUFFER ZONE

Trustee Basher moved, seconded by Trustee Chillemi, and unanimously carried, that the hearing be opened.

Mayor Fixell questioned whether anyone wished to address the Board on this matter. No one appeared.

Trustee Chillemi moved, seconded by Trustee Zollo, and unanimously carried, that the hearing be continued.

Attorney Shumejda explained that the current proposed amendment would modify the special lakes setback which is currently 300 ft, to require the lakes setback to be 300 feet from the water's edge or from the landward edge of the wetlands, which means in most places, the setback would be approximately 500 ft. This amendment would make most of the area from the water's edge to the railroad right away, which the Village owns, the former Putnam line, in the special setback and no building can occur within that area.

Laura Copeland, Grove Street, read an excerpt from Harry Truman's biography and stated that she has known some of the Board for a very long time and hopes that they can withstand the pressures of politics. She wished the Board lots of good luck and that they do the right thing for the Village.
