The meeting began with the Pledge to the Flag.

PROCLAMATION - ALYCE COQUERAN'S DAY

Deputy Mayor Basher presented to Ms. Alyce Coqueran, a proclamation in honor of her 13 years of dedicated service as Site Manager for the Village's Nutrition Program.

WHEREAS Alyce Coqueran was born on Cortland Street in North Tarrytown, later moving to Orchard Street and then to Franklin Courts in Tarrytown, where her seven children were raised, and who have supported her in her many contributions to the Village and personal endeavors; and

WHEREAS Alyce Coqueran retired at the age of 55 from the Westchester County Medical Center; and

WHEREAS Alyce Coqueran from the age of 66 to 79 energetically and lovingly acted as Site Manager for the Village's Nutrition Program for seniors, a program that is essential to the socialization, nutrition, exercise, companionship and general well-being of senior citizens;

NOW THEREFORE BE IT RESOLVED THAT I, Drew Fixell, Mayor of Tarrytown, New York, thank and commend Alyce Coqueran and hereby declare January 4, 2006, Alyce Coqueran Day in the Village of Tarrytown.

REPORTS

Trustee Crucy Burkhardt wished everyone a Happy New Year.

Trustee Butler also wished everyone a Happy New Year and also introduced Dr. Carole Griffiths, Chair of the Environmental Committee, to give a committee update.

Dr. Carole Griffiths stated that the Environmental Committee's mission statement is to promote the stewardship of the environment by increasing public awareness of local environmental concerns. The members of the committee are Claudia Mausner, who chairs the Recycling sub-committee, Carol Tyler, Robert Bujaski, James Lipscomb, who is the tree commission liaison, Rainer Stohl, and Irene Kleinzinger. The committee has visited the Recycling Center in Yonkers and met with Jim Hogan, Director of Environmental Management for Westchester County. Mr. Hogan will be presenting a lecture on recycling at the Senior Center in Tarrytown on Wednesday, January 11th, at 7:30 p.m. This is open to the public. On February 13th, at 7:00 p.m. at the Warner Library, there will be another public meeting on the topic of conserving energy in our homes to save money and also the use of solar energy as an alternative to oil and gas. Hope everyone comes out to attend. They are going to restart the Tarrytown Lakes cleanup. The first Tarrytown Lakes cleanup date will be held on the third weekend of April as part of Earth Day and the Third Friday celebration in Tarrytown.

Deputy Mayor Basher made the following announcement:

The Board of Trustees is holding a joint work shop with the Planning Board on Tuesday, January 10th at 7:30 p.m. at Village Hall to discuss the Ferry Landings FEIS and also on Tuesday, January 17th at 6:00 p.m., before the Board of Trustees regular meeting, they

will hold another joint work shop with the Planning Board to discuss Ferry Landings SEQR findings.

OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD: SPEAKERS HAVE 5 MINUTES BEFORE YIELDING TO THE NEXT PERSON: THEN 3 MINUTES FOR ADDITONAL COMMENTS

John Lynch, 10 Crest Drive, stated that a letter was put together from the River Keeper, Clearwater, and Scenic Hudson on their ideas on a Newburgh site MGP plant similar to our plant. In particular, the groups were concerned about the amount of contamination that was left in place. This is his primary concern about our waterfront site. Mr. Lynch read from an article "For Joe Cotter, acquiring the properties and negotiating an agreement with the party responsible for the coal tar may have seemed to take a lifetime; but within a two-year period, National RE/Sources had the development rights for this 25-acre waterfront site. In September 2003, the NYSDEC approved the Conceptual Remediation Plan, and just over a year later, the remediation was complete. This timing is extremely unusual, since remediation of these sites typically takes 3 to 10 years."

Administrator McCabe stated that there was a very thorough process with respect to the environmental remediation of the site. This began with the remediation plan developed by Haley and Aldrich, a national environmental science company, following with the Department of Environmental Conservation monitoring on a full time basis the remediation that was done. The NYS Department of Environmental Conservation signed off that the initial phase of the remediation was done to their satisfaction. The Department of Health also signed off indicating that the remediation was well done. The Department of Environmental Conservation prescribed a continuing remediation measure that will go on beyond as the project is constructed. It is guaranteed by an environmental easement that the DEC holds on the property. They will continue to have an interest on the property to see that this remediation continues and to see that it is done properly. There will be an annual report from independent engineers submitted. The village hired EEA Inc. for a peer review of the environmental remediation which is part of the FEIS. Haley and Aldrich responded to that and made comments and recommendations that EEA Inc. made, which goes beyond what the DEC required. Their respective reports will be addressed in the findings to establish even further recommendations. Mr. Lynch is invited to submit, in writing, any documentation, while there's still time to be addressed in the findings, and be a part of the future and ongoing remediation.

Joseph Denardo, property owner of 118 Sheldon Avenue, asked the Board the status of the moratorium on "tear downs". Attorney Shumejda stated that there have been discussions at some work sessions about proposed legislations; three sets of documents have been submitted to the Board. The Board is aware that by February 26th, a decision has to be made. The Board may continue the moratorium or choose to enact legislation they deem appropriate. Trustee Butler stated that the Planning and Zoning Committee is studying "tear downs" and will be putting together a report to submit to the Board.

John Lynch, 10 Crest Drive, stated that there is an easement on the waterfront property because part of the voluntary agreement required the institutional controls; basically certain areas couldn't allow kids on it. That was the whole intent of the industrial zone envelope. As soon as the industrial zone envelope was rescinded by this Board that's considered a re-opener as to the voluntary agreement. The FEIS is premised on post remediation of the site. It doesn't include the voluntary agreement. It assumes that everything in the voluntary agreement is going to be met. As soon as you rezoned that back to a water business district area, that voluntary agreement was no longer protective of the site because now residential or commercial can be built on the industrial site. This Board should have requested or demanded to make sure that everybody in this area is being protected. When the law was rescinded stating that there was no environmental impact; that's not true. When you rescind that law, the voluntary agreement no longer was in effect.

ANNOUNCEMENT OF A PUBLIC HEARING TO BE HELD REGARDING THE HANDICAPPED PARKING SPACES SECTION OF THE VILLAGE CODE

Administrator McCabe stated that this public hearing amendment would allow private property owners to have their handicapped parking spaces be policed by our Police Department.

Trustee Pollack moved, seconded by Trustee Butler, and unanimously carried that the following be approved:

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby approves the announcement of a public hearing to be held on January 17, 2006, regarding an amendment to the Village Code with respect to handicapped parking spaces.

BE IT FURTHER RESOLVED that the Village offices to be filled on Election Day, Tuesday, March 21, 2006, and the terms of those offices are as follows:
