BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby approves the following amendment to the Village Vehicle and Traffic Code.

291-77. Schedule XII: Parking Prohibited at All Times

In accordance with the provisions of 291-16, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street	Side	Location
Washington Street, North	West	From a point 123 feet north of Main Street for a distance of 10 feet in a northerly direction.
Washington Street, North	West	From a point 147 feet north of Main St. for a distance of 10 feet.
Washington Street, North	East	From Main Street north for a distance of 85 feet.

#### RESOLUTION REGARDING PARKING METER RATE CHANGE

Trustee Pollack moved, seconded by Trustee McGee, and unanimously carried that the following be approved: Approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby approves the following amendment to the Village Vehicle and Traffic Code.

291-41 Maximum parking time limit; fee; exceptions.

The maximum time limit at the following parking meter spaces so designeated by signs and or markings on Main Street, North Broadway and South Broadway shall be fifteen minutes upon deposit of twenty-five cents, \$ .25.:

- One space on North Broadway-west side 50' south of Central Avenue.
- One space on South Broadway-west side 50' south of Main Street
- One space on Main Street south side 10' east of John Street
- One space on Main Street north side 50' west of North Washington Street.

Spaces so designated by yellow colored parking meters.

## RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO FILE A GRANT APPLICATION FOR FUNDS FROM THE HUDSON RIVER ESTUARY PROGRAM

Trustee McGee moved, seconded by Trustee Pollack, and unanimously carried that the following be approved: Approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown, in accordance with Article 8 of the State Environmental Conservation Law and 6NYCRR Part 617(c) and based upon review of the Environmental Assessment Form and all other materials that were prepared for the Proposed Action, the Village Board of Trustees hereby determines that the Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

#### BE IT FURTHER RESOLVED:

That Stephen A. McCabe, as Village Administrator of the Village of Tarrytown or such persons successor in office, is hereby authorized and directed to file an application for funds from the Hudson River Estuary Program in accordance with the provisions of the Hudson River Estuary Management Act (ECL 11-0306) of the NYS Department of Environmental Conservation in an amount not to exceed \$25,000, and upon approval of said request to enter into and execute a project agreement with the Hudson River Estuary program for such financial assistance to the Village of Tarrytown for the 2006 Hudson River Estuary Grant Contract Number C303198, for the design of a Scenic Hudson Riverwalk Park.
