BE IT FURTHER RESOLVED, that the Board of Trustees shall hold a Special Meeting on Tuesday, March 20, 2007 at 10:00 p.m. at the Tarrytown Village Hall to canvass the vote of the 2007 Village Election.

BE IT FURTHER RESOLVED, that the Board of Trustees request all Election Inspectors vote in their respective, personal designated voting districts and not by absentee vote.

RESOLUTION AUTHORIZING AN INTER-MUNICIPAL AGREEMENT (IMA)
BETWEEN THE VILLAGE AND THE WESTCHESTER COUNTY DEPARTMENT
OF TRANSPORTATION REGARDING COUNTY BUS PASSENGER SHELTERS
IN TARRYTOWN

Trustee Hoyt moved, seconded by Trustee McGee, and unanimously carried that the following be approved: 5-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby approves, and authorizes the Village Administrator to execute, an Inter-Municipal Agreement with Westchester County to provide bus passenger shelters in Tarrytown for a term of five (5) years commencing on April 1, 2006 and expiring on March 31, 2011; whereby after the County has deducted \$75,000 for administrative expenses, the remaining revenue, received from advertising on the shelters, will be divided between the County and cooperating municipalities on a 50/50 ratio, and whereby the locations in Tarrytown will be:

- At the southwest corner of Wildey Street and Central Avenue,
- In front of the medical building on Route 9 and at Leroy Avenue,
- At the southeast corner of Route 119 and Meadow Street

- On the east side of the Tarrytown Metro North Railroad Station,
- On the northwest corner of Benedict Avenue and Prospect Avenue,
- At the eastbound New York Thruway entrance on Route 119,
- On the south side of Route 119 at Talleyrand.
