REPORTS

Mayor Fixell reminded the residents that tomorrow is Election Day in the Village. He thanked Trustee Pollack for her service on the Board.

Trustee McGee thanked Trustee Pollack for her service for the last two years. She knows the Village appreciates all that she has done and she knows that Trustee Pollack will continue to be involved in the Village.

Trustee Hoyt also thanked Trustee Pollack and stated that it was a pleasure working with her this past year and wishes her the best.

Trustee Pollack wished Joe Arduino a happy birthday and thanked the Tarrytown Seniors for their invitation to their fantastic St. Patrick's Day luncheon today. She thanked Marty Anniccherico and his kitchen staff who cooked over 125 lbs. of delicious corned beef. She addressed the Mayor and the Board and the residents of Tarrytown to thank the residents who put her in office and to all those who put their faith in her during her tenure. She will continue to be involved in the Village either on a committee or as a concerned resident. She asks the residents to get involved with our Village and not to be afraid to bring concerns to our Village officials.

Trustee Basher also thanked Trustee Pollack for her service on the Board.

OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD: SPEAKERS HAVE 5 MINUTES BEFORE YIELDING TO THE NEXT PERSON: THEN 3 MINUTES FOR ADDITONAL COMMENTS

Georgia Efthalitsides, 154 Martling Avenue, asked the Board if they had an opportunity to read her e-mail that she sent to them today and if they had any comments. Mayor Fixell stated that he did see the letter late today and would not have a comment at this

time. He will review it. Trustee Pollack stated that the Board has addressed this issue that you did raise at a prior work session.

Tori Weisel, 8 Washington Place, stated the following: 1) she took exception to an election flyer she had received in regard to Tappan Zee Bridge encroachment on neighborhoods in the south end. She and her neighbors have been educating themselves and keeping informed by attending meetings on the Tappan Zee Bridge project and feels that this was a scare tactic. She wants the people in the south end to know, "don't let anyone tell you that they can save your property and that it's about to be taken away." 2) she also thanked Trustee Pollack for all the hard work that she has done. She also stated that in an effort to keep open government flowing, she also took exception to Trustee Pollack's letter that was printed in the River Journal. Where Trustee Pollack implied that the citizen's committees spent valuable time coming up with mission statements to improve and resolve issues, but that matters that were discussed were not paid attention to. Ms. Weisel stated that she worked on the Planning and Zoning Committee and addressed many issues that are now included in the Comprehensive Plan. She wanted to clarify that it's easy to take from this letter that the committees were not effective. Trustee Pollack stated that the letter said that the committees did a lot of hard work that fell by the wayside on the Board's level, not on the committee's level.

John Lynch, 10 Crest Drive, stated that he feels that someone can come into office with zero knowledge of the environment and do a better job that's going on at the waterfront right now.

The Board has requested to have the Tarrytown Volunteer Ambulance Corp include the actual number of points accrued for each member.
