- Hopewell Street, southbound at Exeter Street

Sec 13-171. Same-Designation of intersections.

That Section 13-171 of the Revised Ordinances of the City of Taunton, as amended, be and hereby are further amended by adding the following:

Sec. 13-171 (c), add:

- Exeter Street, westbound at Hamilton Street
- Hamilton street, northbound at Exeter Street
- Hopewell Street, southbound at Exeter Street

All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage. **Motion was made to pass to a third reading. So Voted.**
