Re: Planet Petroleum

Ladies and Gentlemen:

Planet Petroleum has been the subject of ongoing enforcement actions by the Zoning Department, the Board of Health, and the Conservation Agent and Solicitor Estey had been working with them. Mary Jane Benker was scheduled to be in court on this issue on Friday, April 22. The Clerk/Magistrates have been setting benchmarks for compliance with issues such as cleanup and fencing and the owners have failed to meet deadlines.

Because I have had some business with the owners in the past, I do not feel I can ethically appear on the city's behalf in this matter, so I have asked Solicitor Berry to review the situation with Mary Jane and to strategize other enforcement options and perhaps to assign an attorney to take more aggressive action. No one has "dropped the ball" on this issue, but, as we have learned from the Star Theater case, code enforcement mechanisms can be cumbersome and time consuming.

This department hopes to have more satisfactory answers for you over the coming weeks as we develop a new plan of operation.

Dear Mayor and Councilors:

You have requested a report as to what enforcement actions have been taken on Planet Petroleum:

At the present time, no action has been taken on the property located at 274 Winthrop Street known as Planet Petroleum. However, this office has proceeded with enforcement actions in the form of 21D {Non-criminal Disposition} tickets for the abutting property at 272 Winthrop Street known as the "Red House". Approximately 47 tickets were issued to the owner of this Red House property. These tickets were contested in Taunton District Court hearing held on March 18, 2011 – this hearing was continued until April 22, 2011.

Due to the recent resignation of the city solicitor and the assistant solicitor's past dealings with the owners of each of these properties, I feel it is in the best interest of the city to have an attorney present at this hearing. As you are aware, Peter Berry, was appointed as interim City Solicitor at your council meeting on April 12, 2011. I have not had an opportunity to meet with him and familiarize him with the details and history of the situation. Therefore, I have asked the law office to request a one week continuance or to the next available court hearing to obtain legal counsel to represent the city on this matter.

On April 25, 2011 this office is scheduled to meet with Solicitor Berry to review this situation and discuss other enforcement options. However, this office reminds the council that this is a detailed process that can be lengthy and time consuming.

AN ORDINANCE

Chapter 13 Motor Vehicles and Traffic

Be it ordained by the Municipal Council of the City of Taunton as follows:-

That the Revised Ordinances of the City of Taunton, as amended, be and hereby are further amended by:

Section 13-82

Prohibited parking places

Deleting: Broadway, east side, from Leonard Street to a point 405 feet north.

Deleting: Broadway, east side from Randall Street (Crosswalk) to a point 50 feet south.

Adding: Broadway, east side, from Leonard Street to a point 325 feet north.

Section 13-81

Fifteen-minute parking

Deleting: Fruit Street, three spaces directly in front of 22 Fruit Street

Section 13-85

Two-hours parking

Deleting: Pleasant Street, Library patrons only, from 80 feet northwest of Broadway to 184 feet southeast of Washington Street.

Section 13-125

Parking meter zones designated

(2) Thirty-minute meter zones:

Deleting: Broadway, westerly side, from Taunton Green to Pleasant Street

(3) One-hour meter zones:

Deleting: Broadway, easterly side, from Taunton Green to the continuation of the northerly line of Pleasant Street

(4) Two-hour meter zones:

Adding: Broadway, westerly side, from Taunton Green to Pleasant Street

Adding: Broadway, easterly side, from Taunton Green to Leonard Street

Adding: Broadway, westerly side, from Pleasant Street to Governor Street

Adding: Broadway, westerly side, from Governor Street to Washington Street

Adding: Broadway, east side, from in front of the premises known and designated as number 49 Broadway, northerly to Dean Avenue

Adding: Broadway, westerly side, from Dean Avenue for a distance of 295 feet

Adding: Dean Avenue, north side, from Presbrey Avenue to Broadway

Adding: Fruit Street, three spaces directly in front of 22 Fruit Street

Adding: Governor Street, south side, from Washington Street to Broadway

Adding: Governor Street, north side, from Broadway to Washington Street

Adding: Pleasant Street, north side, from Broadway to Washington Street

Adding: Presbrey Avenue, east side, from Leonard Street to Dean Avenue

Section 13-128

Parking meter Fees.

Deleting: The fees for the maximum parking time shall be twenty-five cents (\$0.25) for twenty minutes or any portion thereof.

Adding: The fees for the maximum parking time shall be twenty-five cents (\$0.25) for every interval of twenty (20) minutes or any portion thereof.

Dear Mayor Crowley, City Councilors, and Members of the ZBA,

The members of Taunton Highlands Area Neighborhood Association (THANA) request immediate action on the violations occurring at 272 Winthrop St., Taunton. The Zoning Board of Appeals' unanimous decision ((Case #3056- Dbaib)) rendered on December 16, 2010 mandated the following conditions:

- 1. 6 foot stockade fence shall be erected along the property line abutting 274 Winthrop St., 10 feet back from the property line and 150 feet towards the rear of the property
- 6 foot stockade fence shall be erected along the property line abutting 268 Winthrop St., 10 feet back from the property line and extend 165 feet towards the rear of the property, set back 2 feet from the property line shared with 268 Winthrop St.

These fences were to be installed by **April 15, 2011.** No fencing has been installed, and the accumulation of vehicles on this property, that was to be clear of any debris, is reprehensible. Activity, including car carriers on-loading and off-loading vehicles, continues to occur at all hours of the day and night.

The ZBA members assured the neighbors and taxpayers of the Taunton Highlands area that by granting this petition, they would be able to more adequately enforce any violation. Four months have passed and violations continue at 272 Winthrop St. These violations and others that have been discussed with the Mayor and Council, the condition of the general property on a major thoroughfare in our community, and the disrespect and disregard for the rules and laws of our city and the neighbors all combine into complete frustration and disgust. We want to continue to have trust in our elected and appointed officials and expect that they will protect the quality of life in Taunton that is being infringed upon by violators of such proportions as that at 272 Winthrop St. However, it is becoming increasingly difficult to maintain our trust in our city government.

THANA, as a representative association of the Taunton Highlands area, expects that this property will be cleared, fences installed, and all other violations corrected immediately. In addition, fines that have been issued should be collected. We also trust that this blatant disregard for regulations of Taunton will be strongly considered by all boards when the violators apply for any other permits or variances.
