Dear Maria:

You recently sent me the Municipal Council's request that the City of Taunton be considered for a place on the MIIA Health Benefits Trust Board of Trustees. Having representation of a range of members, both large and small, as well as from throughout the Commonwealth is important. MIIA's connection to the membership and the strength of its programs are enhanced through broad and diverse representation on the Board.

The process for electing members of the Trust Board is set forth in Section 2.03 of the Trust Agreement which Mayor Nunes executed when the City originally joined the Trust. It reads as follows:

"No later than sixty (60) days prior to the Annual Meeting date scheduled by the Trustees, the Secretary shall appoint a nominating committee composed of the Chairman and two (2) other Trustees. No later than thirty (30) days prior to the Annual Meeting, the nominating committee shall mail to all Trustees a report nominating as Trustee, for each position to be filled, at least one (1) person willing and able to serve as Trustee and indicating that, if a Trustee wishes to nominate another person to serve as Trustee, such nomination must be received in writing by the Secretary at least twelve (12) days prior to the Annual Meeting. At that meeting the Trustees in attendance shall elect by ballot the Trustees from those nominated in the nominating committee's report and those nominated as aforesaid by a Trustee. The nominee(s) receiving the greatest number of votes shall be deemed elected as Trustees, shall commence their terms at the conclusion of the meeting, and shall serve for the duration of their terms and until their successors are duly elected."

The nominating committee will be meeting soon to consider candidates for the Trust and I have forwarded the City's interest in having a representative on the Board to the committee.

I should note that currently mayors may not serve on the various MIIA boards without violating the State's conflict of interest statutes. Recognizing the importance of having our member cities represented on the MIIA boards, the MMA had filed legislation to

change this. To date, we have not been successful in achieving passage of that legislation, however, we are committed to re-filing the legislation, particularly given the recent request from the City of Taunton. Getting support for this language from cities would improve the chances of passage by the Legislature.

We value the input a member your size can provide and have been looking at other opportunities for your participation. MIIA has a Health Trust Advisory Committee that could benefit from your participation and I encourage your consideration of that option. Please let me know if you would like further information on that option.

I look forward to our continued discussions on this matter.

Dear Mayor Crowley and Councilors:

On July 2, 2010 the City of Taunton received an advisory from the Alcohol Beverage Control Commission in Boston concerning the expansion of hours of operation on Sunday's beginning at 10AM. Along with the advisory came an e-mail from William A. Kelly, Esq., Legal Counsel to ABCC, explaining the procedures necessary for a city or town to "opt" into this new law.

After speaking to the Assistant City Solicitor, Jordan H. F. Fiore, and following the guidance from Boston, the License Commissioners voted to "opt" into the new law on October 28, 2010. The remaining legal necessity is the approval of the City Council.

As I understand it the nuts and bolts of the new law are as follows:

- The new law allows Section 12 establishments to open at 10 am on Sunday.
- The Local Licensing Authority (LLA) must submit a Form 43 to the ABCC with the Sunday hours of sale for each establishment.
- c. LLA has the right to say yes/no to approval of application of establishment.
- Establishments cannot appeal to the ABCC if LLA says no to the application.

The Board of License Commissioners respectfully requests that the City Council votes to "opt" into the new law. Please feel free to contact me if you have any questions.

Good Afternoon Everyone,

Attached please find an ADVISORY regarding the recently effective NEW LAW ON 10 AM Sunday SALES BY RESTAURANTS, HOTELS, CLUBS, & General On Premises Section 12 License holders.

Effective July 1, 2010 a new law was approved that gives each qualifying local liquor licensing authority the permission to choose whether to allow any or all section 12 license holders to start selling alcoholic beverages as early as 10 AM on Sundays. This new law simply amended section 33B of chapter 138 to allow each city or town to choose to "opt into" the new state law that would give their local liquor licensing authority the discretion to decide whether to grant an additional one (1) hour of sale on Sundays, now starting at 10AM, to any or all of the section 12 license holders in their community, whether the license is a restaurant, hotel, general on premises, club or war veterans club license. Each city and town should check with the Town Counsel or City Solicitor to determine the procedure required to "opt into" this new law.

ABCC approval for these discretionary hours of sale is not required; but an informational "Form 43" with the Sunday hours of sale should be sent to the ABCC, consistent with the practice suggested before this


most recent change in the law. A section 12 license holder who is denied the discretionary hours of sale may not appeal that denial to the ABCC.

THE ALCOHOLIC BEVERAGES CONTROL COMMISSION ("ABCC") ADVISORY

Effective July 1, 2010, the legislature passed a new law authorizing Local Liquor Licensing Authorities ("LLA") to allow M.G.L. c. 138, §12 licensees to sell alcoholic beverages at 10 a.m. on Sundays. This law amends M.G.L. c 138, §33B by allowing each city or town to "opt into" the new law giving their LLA discretion to grant an additional one (1) hour of sale of alcoholic beverages on Sundays, now starting at 10 a.m. to any or all of the §12 licensee in their community. Cities and towns should check with their counsel to determine the procedure required to "opt into" this new law. ABCC approval for these discretionary hours of sale is not required; but as always the LLA must forward an informational "Form 43" with the Sunday hours of sale to the ABCC.

Each §12 licensee should consult with their LLA to determine the necessary steps to get permission to sell alcoholic beverages at 10 a.m. on Sundays. A §12 license holder who is denied the discretionary hour of sale may not appeal that denial to the ABCC.

All licensees should ensure that they are in compliance with the laws of the Commonwealth of Massachusetts, M.G.L. c. 138, § 64, and that sales of alcoholic beverages take place only on the days and hours last approved by the LLA.

NO §12 LICENSEE HAS THE RIGHT TO SELL ALCOHOLIC BEVERAGES EXCEPT DURING THE HOURS the LLA PREVIOUSLY GRANTED ON OR BEFORE JUNE 30, 2010. ANY LICENSEE WHO SELLS BEFORE THE HOURS OF SALE PREVIOUSLY GRANTED ON OR BEFORE JUNE 30, 2010 BY THE LLA VIOLATES THE LAW AND FACES DISCIPLINARY ACTION FROM THE LLA BY SUSPENSION, REVOCATION, CANCELLATION OR MODIFICATION OF THE LICENSE IN ADDITION TO ARREST AND CRIMINAL PROSECUTION FOR THE ILLEGAL SALE OF ALCOHOLIC BEVERAGES.

Dear Lisa:

I write as a follow-up to our recent phone conversation regarding Taunton Green. In your letter to me of 12th November, you wrote that "the City has indicated that they have received numerous complaints on behalf of the residents who have voiced concerns over their safety and the physical structure of this building."

As you and I discussed, I have spoken directly with MassHousing's Rental Management staff regarding the status of this property generally and also about the Agency's most recent interactions with the site. Specifically, I hoped to determine what our staff has heard with regard to complaints about this property.

As you may know, Taunton Green is a 75 unit Section 8 Recap property located in downtown Taunton. It is a four story concrete mercantile building that was converted to elderly housing in 1981. There are also two commercial spaces on the building's ground level. MassHousing staff report that to date, our Agency has received no complaints from tenants or community members regarding the physical condition of the property. After your inquiry, MassHousing staff called and spoke with the property manager for Taunton Green on November 16th. The property manager also indicates that she has not received any such complaints.

Historically, MassHousing's last property management review of Taunton Green was conducted on December 16, 2009 when the site received a satisfactory rating. (This was preceded by a HUD REAC inspection on August 29, 2007.)

In conversations between the site manager and MassHousing staff, the site reports that the elevator has been properly maintained and has a current certification. As far as we know, there have been no violations or discussions with the town regarding the sprinkler/fire system.

If possible, it would be very helpful if you could forward us any specific complaints that you have received or any specific concerns that have been raised. MassHousing will then inquire with the Agent on site and ask them to respond promptly.
