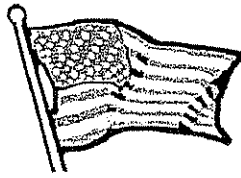
It has been a pleasure to serve my community in this capacity, and I hope that the Commission will continue to enjoy the support of the City in the future.


